1 AN ACT concerning

2 **Maryland Condominium Act – Implied Warranties From Developers – Common**
3 **Amenities**

4 FOR the purpose of requiring that common amenities of a condominium be covered under
5 an implied warranty on common elements from a developer to a council of unit
6 owners; and generally relating to condominiums and implied warranties from
7 developers.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Real Property**

16 11–131.

17 (d) (1) **(I)** In addition to the implied warranties set forth in § 10–203 of this
18 article there shall be an implied warranty on common elements from a developer to the
19 council of unit owners.

1 (II) The warranty shall apply to: [the]

2 1. THE roof, foundation, external and supporting walls,
3 mechanical, electrical, and plumbing systems, and other structural elements; AND

4 2. POOLS, TENNIS AND BASKETBALL COURTS,
5 COMMUNITY CENTERS, AND OTHER COMMON AMENITIES.

6 (2) The warranty shall provide that the developer is responsible for
7 correcting any defect in materials or workmanship, and that the specified common elements
8 are within acceptable industry standards in effect when the building was constructed.

9 (3) (i) The warranty on common elements commences with the first
10 transfer of title to a unit owner.

11 (ii) The warranty of any common elements not completed at the first
12 transfer of title to a unit owner shall commence with the completion of that element OR
13 AMENITY or with its availability for use by all unit owners, whichever occurs later.

14 (iii) The warranty extends for a period of 3 years from
15 commencement under subparagraph (i) or (ii) of this paragraph or 2 years from the date on
16 which the unit owners, other than the developer and its affiliates, first elect a controlling
17 majority of the members of the board of directors for the council of unit owners, whichever
18 occurs later.

19 (4) A suit for enforcement of the warranty on general common elements
20 shall be brought only by the council of unit owners. A suit for enforcement of the warranty
21 on limited common elements may be brought by the council of unit owners or any unit
22 owner to whose use it is reserved.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2020.
