# 2 Motor Vehicle Administration – Records – Voluntary Disclosure of 3 Developmental Disability

4 FOR the purpose of authorizing certain persons to voluntarily disclose certain diagnosed  $\mathbf{5}$ developmental disabilities to the Motor Vehicle Administration; requiring the 6 Administration to keep records of a voluntary disclosure separate from other records; 7 prohibiting the Administration from opening a voluntary disclosure to public 8 inspection, subject to certain exceptions; prohibiting the Administration from using 9 a voluntary disclosure by a person as a basis for referring the person to the Medical Advisory Board; and generally relating to voluntary disclosures of developmental 1011 disabilities to the Motor Vehicle Administration.

1 Subject to § 4-320 of the General Provisions Article, and except as (b)(1) $\mathbf{2}$ otherwise provided by law, all records of the Administration are public records and open to 3 public inspection during office hours. 4 (2)Subject to paragraph (4) of this subsection, the Administrator may classify as confidential and not open to public inspection any record or record entry:  $\mathbf{5}$ 6 (i) That is over 5 years old; or 7 That relates to any happening that occurred over 5 years earlier. (ii) Subject to § 4-320 of the General Provisions Article, a record or record 8 (3)9 entry of any age shall be open to inspection by authorized representatives of any federal, State, or local governmental agency. 10 Subject to paragraph (3) of this subsection, the Administrator may not 11 (4)12open to public inspection any record or record entry that is: 13 (i) All or part of a licensed driver's public driving record; and 14(ii) Over 3 years old. 15(5)Subject to paragraph (6) of this subsection, the Administration may not permit public inspection of a digital photographic image or signature of an individual, or 16 17the actual stored data thereof, recorded by the Administration. 6 (A) A PERSON AT LEAST 18 YEARS OLD WHO IS DIAGNOSED WITH A 7 DEVELOPMENTAL DISABILITY, INCLUDING AUTISM, MAY VOLUNTARILY DISCLOSE 8 THE DIAGNOSIS TO THE ADMINISTRATION.

9 (B) THE ADMINISTRATION SHALL KEEP RECORDS OF A VOLUNTARY 10 DISCLOSURE SEPARATE FROM ANY OTHER RECORDS.

11(C)THE ADMINISTRATION MAY SHARE INFORMATION DISCLOSED UNDER12THIS SECTION ONLY WITH A LAW ENFORCEMENT AGENCY OR A COURT.

13 (D) THE ADMINISTRATOR MAY NOT USE INFORMATION DISCLOSED BY A 14 PERSON UNDER THIS SECTION AS A BASIS FOR REFERRING THE PERSON TO THE 15 MEDICAL ADVISORY BOARD UNDER § 16–118 OF THIS SUBTITLE.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 October 1, 2020.
