- 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 23 That the Laws of Maryland read as follows:
- 24 Article Natural Resources
- 25 10–410.

- 1 (a) (1) Except as otherwise provided in this subsection, a person may not hunt 2 any game bird or mammal on Sundays.
- 3 (2) The following persons may hunt the specified game birds and mammals 4 on Sundays:
- 5 (iv) Subject to the provisions of § 10–411 of this subtitle, in Calvert, 6 Caroline, Carroll, Charles, Harford, Queen Anne's, Somerset, [Talbot,] Wicomico, and 7 Worcester counties, a person hunting deer on private property with a bow and arrow or crossbow during open season on the last three Sundays in October and the second Sunday
- 9 in November;
- 10 (12) (i) This paragraph applies only in Dorchester County.
- 11 (ii) Subject to §§ 10–411 and 10–415 of this subtitle, the Department 12 may allow a person to hunt deer on private property on the second and third Sunday of the 13 deer firearms season.
- 14 (iii) [Subject to §§ 10–411 and 10–415 of this subtitle, the 15 Department may allow a person to hunt deer on private property on a Sunday during the 16 bow hunting season from the first Sunday in October through the second Sunday in January the following year, inclusive.
- 18 (iv)] Subject to §§ 10–411 and 10–415 of this subtitle, the Department 19 may allow a person to hunt deer on private property on a Sunday during the deer muzzle 20 loader season.
- 21 (15) (I) THIS PARAGRAPH APPLIES ONLY IN DORCHESTER COUNTY 22 AND TALBOT COUNTY.
- 23 (II) SUBJECT TO §§ 10–411 AND 10–415 OF THIS SUBTITLE, THE
 24 DEPARTMENT MAY ALLOW A PERSON TO HUNT DEER ON PRIVATE PROPERTY ON A
 25 SUNDAY DURING THE BOW HUNTING SEASON FROM THE FIRST SUNDAY IN OCTOBER
 26 THROUGH THE SECOND SUNDAY IN JANUARY THE FOLLOWING YEAR, INCLUSIVE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020.
