A BILL ENTITLED

1 AN ACT concerning

2 **Labor and Employment – Apprenticeship Career Training Pilot Program for**
3 **Formerly Incarcerated Individuals – Report**

4 FOR the purpose of requiring the Maryland Department of Labor to submit to the General
5 Assembly on or before a certain date each year a certain report on the Apprenticeship
6 Career Training Pilot Program for Formerly Incarcerated Individuals; and generally
7 relating to the Apprenticeship Career Training Pilot Program for Formerly
8 Incarcerated Individuals.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Labor and Employment**

22 11–604.

23 (a) In this section, “Program” means the Apprenticeship Career Training Pilot
24 Program for Formerly Incarcerated Individuals.

1 (b) There is an Apprenticeship Career Training Pilot Program for Formerly
2 Incarcerated Individuals in the Department.

3 (c) The purposes of the Program are:

4 (1) to develop a well-trained, productive construction workforce which
5 meets the needs of the State's economy;

6 (2) to encourage employers to hire formerly incarcerated individuals in the
7 construction industry; and

8 (3) to help employers offset additional costs, if any, associated with hiring
9 apprentices.

10 (I) ON OR BEFORE SEPTEMBER 30 EACH YEAR, THE DEPARTMENT SHALL
11 REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE
12 STATE GOVERNMENT ARTICLE, THE FOLLOWING INFORMATION FOR THE
13 IMMEDIATELY PRECEDING CALENDAR YEAR:

14 (1) THE NUMBER AND TYPES OF EMPLOYERS THAT RECEIVED GRANTS
15 UNDER THE PROGRAM;

16 (2) THE GRANT AMOUNT RECEIVED BY EACH EMPLOYER;

17 (3) THE TOTAL NUMBER OF APPRENTICES AND NUMBER OF
18 APPRENTICES BY EMPLOYER THAT PARTICIPATED IN THE PROGRAM; AND

19 (4) THE PROGRESS IN ACHIEVING THE PURPOSES OF THE PROGRAM
20 SPECIFIED UNDER SUBSECTION (C) OF THIS SECTION.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2020.
