3 Reporting

4 FOR the purpose of repealing certain provisions governing the identification of community
5 health care needs by nonprofit hospitals; repealing certain provisions of law
6 requiring nonprofit hospitals to submit a certain annual community benefits report
7 to the Health Services Cost Review Commission; requiring the Commission to
8 establish a Community Benefit Reporting Workgroup; providing for the composition
9 of the workgroup; requiring the Commission to adopt certain regulations relating to
10 the community health needs of nonprofit hospitals and reporting by nonprofit
11 hospitals regarding community health needs and benefits provided by the hospital;
12 requiring the Commission to establish a method through which State and local
13 governing bodies are made aware of certain meetings; requiring the Commission, on
14 or before a certain date, to ~~issue a certain report, conduct a certain assessment, issue~~
15 ~~certain recommendations,~~ certain information and submit a copy of a certain report
16 to certain committees of the General Assembly; altering certain definitions; making
17 conforming changes; and generally relating to community benefits provided by
18 nonprofit hospitals.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

7 (a) (1) In this section the following words have the meanings indicated.

8 (2) “Commission” means the Health Services Cost Review Commission.

9 (3) **(I)** “Community benefit” means ~~an activity that is intended to~~
10 ~~address community needs and priorities primarily through disease prevention and~~
11 ~~improvement of health status, including:~~

12 ~~(i) [Health] NONREIMBURSABLE HEALTH services provided to~~
13 ~~vulnerable or underserved populations such as Medicaid, Medicare, or Maryland Children’s~~
14 ~~Health Program enrollees;~~

15 ~~(ii) Financial or in-kind support of public health programs;~~

16 ~~(iii) Donations of funds, property, or other resources that contribute~~
17 ~~to a community priority;~~

18 ~~(iv) Health care cost containment activities;~~

28 **4. A FINANCIAL CONTRIBUTION;**

1 **5. A COMMUNITY-BUILDING ACTIVITY, INCLUDING**
 2 **PARTNERSHIPS WITH COMMUNITY-BASED ORGANIZATIONS;**

3 **6. CHARITY CARE;**

4 **7. AN ACTIVITY DESCRIBED UNDER SUBPARAGRAPH (I)**
 5 **OF THIS PARAGRAPH THAT IS FUNDED BY A FOUNDATION;**

6 **8. A MISSION-DRIVEN HEALTH SERVICE;**

7 **9. AN OPERATION RELATED TO AN ACTIVITY DESCRIBED**
 8 **UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH; AND**

9 **10. FINANCIAL OR IN-KIND SUPPORT OF THE MARYLAND**
 10 **BEHAVIORAL HEALTH CRISIS RESPONSE SYSTEM.**

11 (4) “COMMUNITY BENEFIT REPORTING WORKGROUP” MEANS THE
 12 COMMUNITY BENEFIT REPORTING WORKGROUP ESTABLISHED IN ACCORDANCE
 13 WITH SUBSECTION (B) OF THIS SECTION.

14 (5) “Community HEALTH needs assessment” means ~~the~~ the process
 15 **REQUIRED BY THE AFFORDABLE CARE ACT** by which unmet community health care
 16 needs and priorities are identified; ~~A COMMUNITY HEALTH NEEDS ASSESSMENT~~
 17 ~~CONDUCTED BY A NONPROFIT HOSPITAL IN ACCORDANCE WITH § 501(R)(3) OF THE~~
 18 **INTERNAL REVENUE CODE.**

19 [(b) In identifying community health care needs, a nonprofit hospital:

20 (1) Shall consider, if available, the most recent community needs
 21 assessment developed by the Department or the local health department for the county in
 22 which the nonprofit hospital is located;

23 (2) May consult with community leaders and local health care providers;
 24 and

25 (3) May consult with any appropriate person that can assist the hospital in
 26 identifying community health needs.

27 (c) (1) Each nonprofit hospital shall submit an annual community benefit
 28 report to the Health Services Cost Review Commission detailing the community benefits
 29 provided by the hospital during the preceding year.

30 (2) The community benefit report shall include:

31 (i) The mission statement of the hospital;

- 1 (ii) A list of the initiatives that were undertaken by the hospital;
- 2 (iii) The cost to the hospital of each community benefit initiative;
- 3 (iv) The objectives of each community benefit initiative;
- 4 (v) A description of efforts taken to evaluate the effectiveness of each
5 community benefit initiative;
- 6 (vi) A description of gaps in the availability of specialist providers to
7 serve the uninsured in the hospital; and
- 8 (vii) A description of the hospital's efforts to track and reduce health
9 disparities in the community that the hospital serves.

10 (d) (1) The Commission shall compile the reports required under subsection
11 (c) of this section and issue an annual Nonprofit Hospital Community Health Benefit
12 Report.

13 (2) In addition to the information required under paragraph (1) of this
14 subsection, the Nonprofit Hospital Community Health Benefit Report shall contain a list
15 of the unmet community health care needs identified in the most recent community needs
16 assessment prepared by the Department or local health department for each county.

17 (3) The Nonprofit Hospital Community Health Benefit Report shall be
18 made available to the public free of charge.

19 (4) The Commission shall submit a copy of the annual Nonprofit Hospital
20 Community Health Benefit Report, subject to § 2-1257 of the State Government Article, to
21 the House Health and Government Operations Committee and the Senate Finance
22 Committee.

23 (e) The Commission shall adopt regulations, in consultation with representatives
24 of nonprofit hospitals, that establish:

25 (1) A standard format for reporting the information required under this
26 section;

27 (2) The date on which nonprofit hospitals must submit the annual
28 community benefit reports; and

29 (3) The period of time that the annual community benefit report must
30 cover.]

31 **(B) (1) THE COMMISSION SHALL ESTABLISH A COMMUNITY BENEFIT**
32 **REPORTING WORKGROUP.**

1 (2) THE COMMUNITY BENEFIT REPORTING WORKGROUP SHALL BE
2 COMPOSED OF INDIVIDUALS AND STAKEHOLDER GROUPS THAT HAVE KNOWLEDGE
3 OF AND ARE IMPACTED BY HOSPITAL COMMUNITY BENEFIT SPENDING.

4 (C) THE COMMISSION SHALL ADOPT REGULATIONS, ~~IN CONSULTATION~~
5 ~~WITH REPRESENTATIVES OF NONPROFIT HOSPITALS AND~~ TO IMPLEMENT THE
6 RECOMMENDATIONS OF THE COMMUNITY BENEFIT REPORTING WORKGROUP,
7 THAT:

8 (1) ESTABLISH A STANDARD FORMAT FOR REPORTING THE
9 INFORMATION REQUIRED UNDER THIS SUBSECTION;

10 (2) SPECIFY THE DATE BY WHICH EACH NONPROFIT HOSPITAL IS
11 REQUIRED TO SUBMIT THE ~~REPORTS REQUIRED UNDER THIS SUBSECTION TO THE~~
12 COMMISSION ANNUAL COMMUNITY BENEFIT REPORT;

13 (3) REQUIRE EACH NONPROFIT HOSPITAL TO ~~IDENTIFY THE~~
14 ~~HOSPITAL'S COMMUNITY HEALTH NEEDS WHEN PREPARING ITS COMMUNITY~~
15 ~~HEALTH NEEDS ASSESSMENT BY CONSULTING WITH:~~

16 (I) ~~CONSUMERS AND OTHER MEMBERS OF THE PUBLIC;~~

17 (II) ~~HEALTH CARE PROVIDERS THAT ARE NOT EMPLOYED BY A~~

20 (IV) ~~COMMUNITY LEADERS;~~

27 INTERESTS OF THAT COMMUNITY, INCLUDING INDIVIDUALS WITH SPECIAL
28 KNOWLEDGE OF OR EXPERTISE IN PUBLIC AND BEHAVIORAL HEALTH IN
29 ACCORDANCE WITH § 501(R)(3) OF THE INTERNAL REVENUE CODE;

30 (4) ~~REQUIRE EACH NONPROFIT HOSPITAL TO HOLD MEETINGS FOR~~
31 ~~THE PURPOSE OF SOLICITING COMMENTS AND FEEDBACK FROM THE GENERAL~~

~~PUBLIC ON THE NONPROFIT HOSPITAL'S PROPOSED COMMUNITY BENEFIT INITIATIVES MEANT TO ADDRESS THE IDENTIFIED COMMUNITY HEALTH NEEDS FOR THE FOLLOWING YEAR; AND~~

~~(5) REQUIRE EACH NONPROFIT HOSPITAL TO SUBMIT AN ANNUAL COMMUNITY BENEFIT REPORT TO THE COMMISSION THAT DETAILS THE COMMUNITY BENEFITS PROVIDED BY THE HOSPITAL DURING THE IMMEDIATELY PRECEDING YEAR AND THAT INCLUDES:~~

(4) REQUIRE EACH NONPROFIT HOSPITAL TO CONDUCT ITS COMMUNITY HEALTH NEEDS ASSESSMENT IN CONSULTATION WITH COMMUNITY MEMBERS AS RECOMMENDED BY THE COMMUNITY BENEFIT REPORTING WORKGROUP AND TO SUBMIT AN ANNUAL COMMUNITY BENEFITS REPORT TO THE COMMISSION DETAILING THE COMMUNITY BENEFITS PROVIDED BY THE HOSPITAL DURING THE PRECEDING YEAR THAT INCLUDES:

(I) THE MISSION STATEMENT OF THE HOSPITAL;

(II) A LIST OF THE ~~COMMUNITY BENEFIT INITIATIVES UNDERTAKEN BY THE HOSPITAL~~ ACTIVITIES THAT WERE UNDERTAKEN BY THE HOSPITAL TO ADDRESS THE IDENTIFIED COMMUNITY HEALTH NEEDS WITHIN THE HOSPITAL'S COMMUNITY;

(III) THE COST TO THE HOSPITAL OF EACH COMMUNITY BENEFIT INITIATIVE ACTIVITY;

(IV) ~~THE IMPACT OF EACH COMMUNITY BENEFIT INITIATIVE ON IDENTIFIED COMMUNITY HEALTH NEEDS AND AN ITEMIZED ACCOUNTING OF THE COSTS OF EACH COMMUNITY BENEFIT INITIATIVE~~ A DESCRIPTION OF HOW EACH OF THE LISTED ACTIVITIES ADDRESSES THE COMMUNITY HEALTH NEEDS OF THE HOSPITAL'S COMMUNITY;

(V) A DESCRIPTION OF ~~THE HOSPITAL'S EFFORTS TO EVALUATE THE EFFECTIVENESS OF EACH COMMUNITY BENEFIT INITIATIVE~~ EFFORTS TAKEN TO EVALUATE THE EFFECTIVENESS OF EACH COMMUNITY BENEFIT ACTIVITY;

(VI) A DESCRIPTION OF GAPS IN THE AVAILABILITY OF PROVIDERS TO SERVE ~~UNINSURED INDIVIDUALS AT THE HOSPITAL~~ THE COMMUNITY;

(VII) A DESCRIPTION OF THE HOSPITAL'S EFFORTS TO TRACK AND REDUCE HEALTH DISPARITIES IN THE COMMUNITY THAT THE HOSPITAL SERVES;

1 (VIII) A LIST OF THE UNMET COMMUNITY HEALTH NEEDS
2 IDENTIFIED IN THE MOST RECENT COMMUNITY HEALTH NEEDS ASSESSMENT; AND

3 (IX) A LIST OF TAX EXEMPTIONS THE HOSPITAL CLAIMED
4 DURING THE IMMEDIATELY PRECEDING TAXABLE YEAR, IN ACCORDANCE WITH
5 STATE LAW.

6 (D) THE COMMISSION SHALL ESTABLISH A METHOD THROUGH WHICH
7 STATE AND LOCAL GOVERNING BODIES ARE MADE AWARE OF THE MEETINGS OF THE
8 COMMUNITY BENEFIT REPORTING WORKGROUP.

9 SECTION 2. AND BE IT FURTHER ENACTED, That:

10 (a) On or before ~~October~~ December 1, 2020, the Health Services Cost Review
11 Commission shall compile a report on the steps taken to update the community benefit
12 reporting process that includes:

13 ~~(1) issue a report on the steps taken to assess the extent to which each~~
14 ~~nonprofit hospital's community benefit spending addresses the community health needs of~~
15 ~~its service area;~~

16 ~~(2) conduct an assessment of each nonprofit hospital's process for soliciting~~
17 ~~public comments on the health needs of the hospital's community and the hospital's process~~
18 ~~for incorporating the public comments into its community health needs assessment;~~

19 ~~(3) issue recommendations for methodologies and processes for the~~
20 ~~Maryland Department of Health and local health departments to certify whether a~~
21 ~~hospital's spending on community benefit initiatives has been directed to a community~~
22 ~~health need identified in the hospital's community health needs assessment; and~~

23 ~~(4) issue recommendations on the process to develop a community health~~
24 ~~needs assessment.~~

25 (1) a description of each hospital's process for soliciting input in the
26 development of the community health needs assessment for the purpose of § 501(r)(3) of
27 the Internal Revenue Code; and

28 (2) recommendations for the Maryland Department of Health and the local
29 health departments to assess the effectiveness of hospitals' community benefit spending to
30 address the community health needs.

31 (b) On or before ~~October~~ December 1, 2020, the Commission shall submit a copy
32 of the ~~report required under subsection (a) of this section~~ annual Nonprofit Hospital
33 Community Health Benefit Report to the House Health and Government Operations
34 Committee and the Senate Finance Committee in accordance with § 2-1257 of the State
35 Government Article.

1 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2020.
