3 FOR the purpose of establishing the Maryland Healthy Soils Grant Program; establishing 4 the purpose of the Grant Program; establishing a certain eligibility requirement; $\mathbf{5}$ requiring the Department of Agriculture to implement and administer the Grant 6 Program; requiring the Department to adopt certain regulations; requiring the Department to use a certain evaluation tool to calculate certain figures; authorizing, 7 8 beginning in a certain fiscal year, and each fiscal year thereafter, the Governor to 9 include in the budget bill a certain appropriation for the Grant Program; requiring the Department to report certain information to certain committees of the General 10 11 Assembly on a certain date each year; requiring the Governor to offset a certain 12appropriation to the Grant Program to reflect the repeal of a certain sales and use tax exemption; defining certain terms; and generally relating to the Maryland 13 14 Healthy Soils Grant Program.

(1) machinery or equipment used to produce bituminous concrete ON OR
BEFORE JULY 1, 2020; or

(2) electricity, fuel, and other utilities used to operate that machinery orequipment.

SECTION 2. AND BE IT FURTHER ENACTED, That the Governor shall offset the appropriation authorized in § 2–1902(f) of the Agriculture Article, as enacted by Section 1 of this Act, with the funds collected as a result of the repeal of the sales and use tax exemption in § 11–210(a)(1) of the Tax – General Article, as enacted by Section 1 of this Act.
