County Boards and Public and Nonpublic Prekindergarten Programs and Schools – Discrimination – Prohibition

FOR the purpose of prohibiting a county board, public prekindergarten program, nonpublic prekindergarten program that receives State funds, public primary or secondary school, or nonpublic primary or secondary school that receives State funds from discriminating against a person because of certain factors, refusing enrollment of, expelling, or withholding privileges from any student or prospective student because of certain factors, and from taking certain retaliatory actions against a student or parent or guardian of a student who files a complaint alleging certain discrimination; authorizing a certain person to file a certain complaint with the State Superintendent of Schools; requiring the complaint to specify certain information; authorizing a certain parent or guardian to file a certain complaint on behalf of a minor; requiring the State Superintendent, on receipt of a certain complaint, to provide notice of the complaint to certain parties; requiring the parties to submit a certain response within a certain period of time; requiring the State Superintendent to attempt to mediate a certain agreement; requiring the State Superintendent to issue a certain statement of the mediation findings and agreement in a certain manner under certain circumstances; requiring the State Superintendent to issue a certain decision within a certain period of time under certain circumstances; requiring that certain prekindergarten providers that violate a certain law are subject to certain penalties; requiring the decision to be in writing and contain certain information; authorizing the State Superintendent to impose a certain
