Harford County - Alcoholic Beverages - Resort Complex License

- 3 FOR the purpose of establishing in Harford County a resort complex license; authorizing the Board of License Commissioners for Harford County to issue one resort complex 4 5 license to a certain person; specifying that the license authorizes the holder to sell 6 beer, wine, and liquor at certain outlets in the resort complex; establishing the days 7 and times during which a license holder may serve alcoholic beverages; exempting 8 the resort complex license from a certain license quota or restriction; establishing 9 that certain areas in a resort complex may be excluded from the licensed premises; 10 providing that a resort complex for which the license is issued is subject to certain 11 alcohol awareness training requirements; establishing a certain license fee fees; 12 defining a certain term; and generally relating to alcoholic beverages licenses in 13 Harford County.

- 1 (3) BARS OR COUNTERS AT ONE OR MORE LOCATIONS IN THE RESORT 2 COMPLEX DAILY FOR ON-PREMISES CONSUMPTION;
- 3 (4) ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR 4 CULINARY EDUCATION AND ENTERTAINMENT WHICH MAY INCLUDE OFF-PREMISES
- 5 CONSUMPTION; AND
- 6 (5) ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR 7 OFF-PREMISES CONSUMPTION.
- 8 (E) A LICENSE HOLDER MAY SERVE ALCOHOLIC BEVERAGES:
- 9 (1) AT ONE OR MORE OUTSIDE OUTLETS IN THE RESORT COMPLEX ON MONDAY THROUGH SUNDAY, FROM 6 A.M. TO MIDNIGHT;
- 11 (2) AT ONE OR MORE INSIDE OUTLETS IN THE RESORT COMPLEX:
- 12 (I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.
- 13 THE FOLLOWING DAY; AND
- 14 (II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT; AND
- 15 (3) AT ONE DESIGNATED OUTLET FOR OFF-PREMISES CONSUMPTION:
- 16 (I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.
- 17 THE FOLLOWING DAY; AND
- 18 (II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT.
- 19 (F) A RESORT COMPLEX LICENSE IS EXEMPT FROM ANY QUOTA OR
- 20 RESTRICTION ON OFF-SALE LICENSES ISSUED FOR THE ELECTION DISTRICT IN
- 21 WHICH THE RESORT COMPLEX IS LOCATED.
- 22 (G) (1) CERTAIN AREAS IN A RESORT COMPLEX MAY BE EXCLUDED FROM
- 23 THE PORTION OF THE PROPERTY THAT IS CONSIDERED TO BE THE LICENSED
- 24 PREMISES.
- 25 (2) A PERSON OTHER THAN THE RESORT COMPLEX LICENSE HOLDER
- 26 MAY OBTAIN A DIFFERENT CLASS OF LICENSE FOR AN AREA EXCLUDED UNDER
- 27 PARAGRAPH (1) OF THIS SUBSECTION.
- 28 (H) A RESORT COMPLEX FOR WHICH THE LICENSE IS ISSUED IS SUBJECT TO
- 29 THE ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4–505 OF THIS
- 30 ARTICLE.

(II) (I) (1)	THE ANNUAL INITIAL LICENSE FEE IS \$3,500.
<u>(2)</u>	BEGINNING MAY 1, 2021, THE ANNUAL LICENSE FEE IS \$6,000.
