## A BILL ENTITLED

1 AN ACT concerning

## 2 Harford County – Telecommunications Service Tax – Authorization

3 FOR the purpose of authorizing the governing body of Harford County to impose, by law, 4 and collect a sales and use tax on telecommunications service in Harford County  $\mathbf{5}$ under certain circumstances; providing that the tax rate imposed may not exceed a 6 certain amount; requiring that the tax be itemized on the telecommunications 7 service bill and collected by the telecommunications service vendor on behalf of 8 Harford County; providing that the net proceeds of the tax may be used only for 9 expenditures of the Harford County public school system and may not be used to supplant certain other funding; defining certain terms; and generally relating to 1011 authorization of a telecommunications service tax in Harford County.
