- 1 **(A)** For each of fiscal years 2020 and 2021, the Governor shall include in the State 2 budget an annual appropriation to the Baltimore Symphony Orchestra of \$1,600,000.
- 3 (B) FOR EACH OF FISCAL YEARS 2022 THROUGH 2026, THE GOVERNOR 4 SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE 5 BALTIMORE SYMPHONY ORCHESTRA AS FOLLOWS:
- 6 (1) FOR FISCAL YEAR 2022, \$1,500,000;
- 7 (2) FOR FISCAL YEAR 2023, \$1,300,000;
- 8 (3) FOR FISCAL YEAR 2024, \$1,100,000;

[Section 1 of this Act shall remain effective for a period of 2 years and, at the end of June 30, 2021, Section 1 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.] Section 2 of this Act shall remain effective for a period of 1 year and, at the end of June 30, 2020, Section 2 of this Act with no further action required by the Canaral Assembly, shall be abrogated and of no
