## A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Class B and Class H Licenses –**  
3 **Renewals**

4 FOR the purpose of requiring a license holder, before each renewal of a Class B or Class H  
5 alcoholic beverages license in Anne Arundel County, to attest in a sworn statement  
6 that the gross receipts from food sales for a certain period of time immediately  
7 preceding the application for renewal were equal to at least a certain percentage of  
8 the gross receipts from the sale of food and alcoholic beverages; and generally  
9 relating to the renewal of Class B and Class H alcoholic beverages licenses in Anne  
10 Arundel County.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
22 That the Laws of Maryland read as follows:

23 **Article – Alcoholic Beverages**

3 (a) There is a Class B beer and light wine license.

4 (b) The license authorizes the license holder to sell beer and light wine at a hotel  
5 or restaurant, at retail, at the place described in the license, for on- and off-premises  
6 consumption.

7 (c) **BEFORE EACH RENEWAL OF THE LICENSE, THE LICENSE HOLDER SHALL**  
8 **ATTEST IN A SWORN STATEMENT THAT THE GROSS RECEIPTS FROM FOOD SALES FOR**  
9 **THE 12-MONTH PERIOD IMMEDIATELY PRECEDING THE APPLICATION FOR**  
10 **RENEWAL WERE AT LEAST EQUAL TO 51% OF THE GROSS RECEIPTS FROM THE SALE**  
11 **OF FOOD AND ALCOHOLIC BEVERAGES.**

12 (D) The annual license fee is \$480.

13 11-805.

14 (a) There is a Class H beer and light wine license.

15 (b) The license authorizes the license holder to sell beer and light wine at a hotel  
16 or restaurant, at retail, at the place described in the license, for on-premises consumption.

17 (c) **BEFORE EACH RENEWAL OF THE LICENSE, THE LICENSE HOLDER SHALL**  
18 **ATTEST IN A SWORN STATEMENT THAT THE GROSS RECEIPTS FROM FOOD SALES FOR**  
19 **THE 12-MONTH PERIOD IMMEDIATELY PRECEDING THE APPLICATION FOR**  
20 **RENEWAL WERE AT LEAST EQUAL TO 51% OF THE GROSS RECEIPTS FROM THE SALE**  
21 **OF FOOD AND ALCOHOLIC BEVERAGES.**

22 (D) The annual license fee is \$360.

23 11-902.

24 (a) There is a Class B beer, wine, and liquor license.

25 (b) The Board may issue the license for use by a restaurant that:

26 (1) has ample space and accommodations for regularly preparing, selling,  
27 and serving hot meals to the public at least twice daily;

28 (2) is equipped with a public dining room with sufficient tables, chairs,  
29 cutlery, and glassware to serve the meals prepared in the restaurant;

30 (3) is equipped with a kitchen that has complete facilities and utensils for

1 preparing and serving hot and cold meals to the public; and

2 (4) employs a sufficient number of cooks and wait staff to serve the number  
3 of customers accommodated in the dining room.

4 (c) The license authorizes the license holder to sell beer, wine, and liquor at retail  
5 at the place described in the license, for on- or off-premises consumption.

6 (d) **BEFORE EACH RENEWAL OF THE LICENSE, THE LICENSE HOLDER SHALL**  
7 **ATTEST IN A SWORN STATEMENT THAT THE GROSS RECEIPTS FROM FOOD SALES FOR**  
8 **THE 12-MONTH PERIOD IMMEDIATELY PRECEDING THE APPLICATION FOR**  
9 **RENEWAL WERE AT LEAST EQUAL TO 51% OF THE GROSS RECEIPTS FROM THE SALE**  
10 **OF FOOD AND ALCOHOLIC BEVERAGES.**

11 (E) The annual fee for the license is \$1,080.

12 11-905.

13 (a) There is a Class H beer, wine, and liquor license.

14 (b) The license authorizes the license holder to sell beer, wine, and liquor at retail  
15 at the place described in the license, for on-premises consumption.

16 (c) The license holder may sell beer, wine, and liquor during the hours and days  
17 as set out under § 11-2004(e) of this title.

18 (d) **BEFORE EACH RENEWAL OF THE LICENSE, THE LICENSE HOLDER SHALL**  
19 **ATTEST IN A SWORN STATEMENT THAT THE GROSS RECEIPTS FROM FOOD SALES FOR**  
20 **THE 12-MONTH PERIOD IMMEDIATELY PRECEDING THE APPLICATION FOR**  
21 **RENEWAL WERE AT LEAST EQUAL TO 51% OF THE GROSS RECEIPTS FROM THE SALE**  
22 **OF FOOD AND ALCOHOLIC BEVERAGES.**

23 (E) The annual license fee is \$960.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
25 1, 2020.
