# 1 AN ACT concerning

# Motor Vehicle Registration – Exception for Golf Carts – Hoopers Island <u>and</u> <u>Taylors Island</u>

4 FOR the purpose of creating an exception from motor vehicle registration requirements  $\mathbf{5}$ under certain circumstances for golf carts on Upper or Middle Hoopers Island or 6 Taylors Island; providing that a person who operates a golf cart on a highway on 7 Upper or Middle Hoopers Island or Taylors Island may operate the golf cart only on 8 certain roads at certain times and only if the golf cart is equipped with certain 9 lighting devices; requiring a person who operates a golf cart on a highway on Upper 10 or Middle Hoopers Island or Taylors Island to keep as far to the right as feasible and 11 possess a valid driver's license; authorizing the County Council of Dorchester County 12to designate highways on which a person may operate a golf cart on Upper or Middle Hoopers Island or Taylors Island; and generally relating to an exception to motor 13 vehicle registration requirements for golf carts on Upper or Middle Hoopers Island 14 or Taylors Island. 15

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND That the Laws of Maryland read as follows:
Article – Transportation
13–402.
(a) (1) Except as otherwise provided in this section or elsewhere in the Maryland Vehicle Law, each motor vehicle, trailer, semitrailer, and pole trailer driven or a highway shall be registered under this subtitle.
(c) Registration under this subtitle is not required for:
(12) A golf cart that is operated on a highway in accordance with §§ 21–104.2 through [21–104.4] <b>21–104.5</b> of this article;
21-104.5.
(A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A PERSON WHO OPERATES A GOLF CART ON A HIGHWAY ON UPPER OR MIDDLE HOOPERS ISLAND <u>OR TAYLORS ISLAND</u> , DORCHESTER COUNTY, WITHOUT REGISTRATION AS AUTHORIZED UNDER § 13–402(C)(12) OF THIS ARTICLE:
(1) MAY OPERATE THE GOLF CART ONLY:
(I) ON A HIGHWAY ON WHICH THE MAXIMUM POSTED SPEED LIMIT DOES NOT EXCEED 30 MILES PER HOUR;
(II) BETWEEN DAWN AND DUSK; AND
(III) IF THE GOLF CART IS EQUIPPED WITH LIGHTING DEVICES AS REQUIRED BY THE ADMINISTRATION;
(2) SHALL KEEP THE GOLF CART AS FAR TO THE RIGHT OF THE

# (3) SHALL POSSESS A VALID DRIVER'S LICENSE.

(B) THE COUNTY COUNCIL OF DORCHESTER COUNTY MAY DESIGNATE BY
RESOLUTION THE HIGHWAYS ON UPPER OR MIDDLE HOOPERS ISLAND <u>OR TAYLORS</u>
<u>ISLAND</u> ON WHICH A PERSON MAY OPERATE A GOLF CART.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2020.
