Vehicle Laws - Manufacturers and Dealers - Advertisements Prices Listed on <u>Dealer Websites</u>

FOR the purpose of providing that a manufacturer, distributor, or factory branch may not prohibit a dealer from <u>listing on the dealer's website</u> advertising a vehicle for sale or lease at a certain price or coerce or require a dealer to change the advertising medium
for a certain price <u>list a certain price on the dealer's website or take an adverse action</u>
against a dealer for listing a certain price on the dealer's website; requiring a
contract for the sale of a vehicle by a dealer to contain a certain statement; defining

8 (b) A dealer or an agent or employee of a dealer may not by any means advertise 9 or offer to the public any vehicle without intent to sell it as advertised or offered.
