- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 15 That the Laws of Maryland read as follows:
- 16 Article Transportation
- 17 **4–408.**
- 18 (A) FOR ANY FISCAL YEAR THAT AN APPROPRIATION IS INCLUDED IN THE
- 19 STATE BUDGET FOR THE PLANNING, ENGINEERING, RIGHT-OF-WAY ACQUISITION,
- 20 AND CONSTRUCTION OF A THIRD BRIDGE THAT CROSSES THE CHESAPEAKE BAY,
- 21 THE GOVERNOR SHALL INCLUDE IN THE STATE BUDGET A CAPITAL GRANT FOR
- 22 EACH COUNTY IN WHICH THE BRIDGE ORIGINATES OR TERMINATES FOR
- 23 TRANSPORTATION INFRASTRUCTURE IMPROVEMENTS.
- 24 (B) FOR EACH COUNTY, THE CAPITAL GRANT ISSUED UNDER THIS SECTION:

- 1 (1) SHALL EQUAL 25% OF THE AMOUNT APPROPRIATED FOR THE
- 2 FISCAL YEAR FOR THE PLANNING, ENGINEERING, RIGHT-OF-WAY ACQUISITION,
- 3 AND CONSTRUCTION OF THE BRIDGE; AND
- 4 (2) MAY BE USED ONLY FOR TRANSPORTATION INFRASTRUCTURE
- 5 IMPROVEMENTS NECESSITATED BY OR RELATED TO THE CONSTRUCTION OF THE
- 6 BRIDGE.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 8 1, 2020.
