A BILL ENTITLED

1 AN ACT concerning

2 **Department of Veterans Affairs – Homes for Veterans – Veterans of Uniformed**
3 **Service**

4 FOR the purpose of altering the eligibility for a certain veteran to reside at a home for
5 veterans that is supervised by the Department of Veterans Affairs to include a
6 certain veteran of active service with a uniformed service of the United States;
7 making a stylistic change; and generally relating to homes for veterans that are
8 supervised by the Department of Veterans Affairs.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – State Government**

22 9–901.

1 (a) In this subtitle the following words have the meanings indicated.

2 (b) “Department” means the Department of Veterans Affairs.

3 (c) “Secretary” means the Secretary of Veterans Affairs.

4 (d) Except as otherwise provided in [§§ 9–906 and 9–907 of] this subtitle,
5 “veteran” means an individual who served on active duty in the armed forces of the United
6 States, other than for training, and was discharged or released under conditions other than
7 dishonorable.

9 “Home” means the home or homes for veterans that the Department supervises.

10 9–911.

11 (a) In accordance with the regulations of the Department and applicable law, the
12 home shall be open:

13 (1) to a veteran who:

14 (i) has an honorable discharge from [the armed forces] **ACTIVE**
15 **SERVICE WITH A UNIFORMED SERVICE OF THE UNITED STATES, INCLUDING THE:**

16 1. **ARMY;**

17 2. **MARINE CORPS;**

18 3. **NAVY;**

19 4. **AIR FORCE;**

20 5. **COAST GUARD;**

21 6. **PUBLIC HEALTH SERVICE COMMISSIONED CORPS;**

22 **AND**

23 7. **NATIONAL OCEANIC AND ATMOSPHERIC**
24 **ADMINISTRATION COMMISSIONED OFFICER CORPS; and**

25 (ii) is a resident of the State as defined in regulations adopted by the
26 Secretary; or

27 (2) to a spouse of an eligible veteran.

1 (b) (1) The Department may charge an individual a reasonable fee for
2 residence in the home.

3 (2) The Department shall set the fee in accordance with the ability of an
4 individual to pay. However, the fee may not exceed the cost of maintaining the resident in
5 the home and shall allow the resident enough money for necessary and incidental expenses.

6 (c) A resident may be discharged in accordance with the regulations of the
7 Department and applicable law.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
9 1, 2020.
