(a) "Public school employee" means a certificated professional individual 2 (e) (1) who is employed by a public school employer or an individual of equivalent status in 3 4 Baltimore City, except for a county superintendent or an individual designated by the public school employer to act in a negotiating capacity as provided in § 6-408(c) of this 5 subtitle. 6 7 (2)In Montgomery County, "public school employees" include: 8 (i) Certificated and noncertificated substitute teachers employed by 9 the public school employer for at least 7 days before March 1 of the school fiscal year ending June 30, 1978, and each year after; and 10 11 Home and hospital teachers employed by the public school (ii) 12 employer for at least 7 days before March 1 of the school fiscal year ending June 30, 2000, 13 and each year after. 14 In Baltimore County, "public school employee" includes a secondary (3)15 school nurse, an elementary school nurse, and a special school nurse. 16 In Frederick County, "public school employee" includes a social worker (4) 17 employed by a public school employer. In Prince George's County, "public school employee" includes home and 18 19 hospital teachers and Junior Reserve Officer Training Corps (JROTC) instructors. 20 In Baltimore County, Calvert County, Charles County, and Garrett 21County, "public school employee" includes Junior Reserve Officer Training Corps (JROTC) 22instructors. 23 In Carroll County, "public school employee" includes: (7) 24(i) A registered nurse; [and] 25Supervisory noncertificated employees as defined under § (ii) 266–501(i) of this title; AND (III) JUNIOR RESERVE OFFICER TRAINING CORPS (JROTC) 27 28 INSTRUCTORS.

SECTION 2. AND BE IT FURTHER ENACTED. That this Act shall take effect July
