### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Mental Health – Confidentiality of Medical Records and Emergency Facilities**  
3 **List – ~~Comprehensive Crisis Response Centers, Crisis Stabilization Centers, and~~**  
4 **~~Crisis Treatment Centers~~**

5 FOR the purpose of altering the definition of “health care provider” for the purposes of  
6 certain provisions of law governing the confidentiality of medical records to include  
7 comprehensive crisis response centers, crisis stabilization centers, and crisis  
8 treatment centers; providing that the list of emergency facilities the Maryland  
9 Department of Health is required to publish may include comprehensive crisis  
10 response centers, crisis stabilization centers, ~~and~~ crisis treatment centers, and  
11 outpatient mental health clinics; requiring the Department to develop a certain model  
12 program structure; requiring the Department to submit a certain report to the General  
13 Assembly on or before a certain date each year; prohibiting the Department from  
14 adding emergency facilities to a certain list before certain model facility standards

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 15 That the Laws of Maryland read as follows:

16 **Article – Health – General**

17 4-301.

18 (a) In this subtitle the following words have the meanings indicated.

19 (h) (1) “Health care provider” means:

20 (i) A person who is licensed, certified, or otherwise authorized under  
 21 the Health Occupations Article or § 13-516 of the Education Article to provide health care  
 22 in the ordinary course of business or practice of a profession or in an approved education or  
 23 training program; or

24 (ii) A facility where health care is provided to patients or recipients,  
 25 including a facility as defined in § 10-101(g) of this article, a hospital as defined in §  
 26 19-301 of this article, a related institution as defined in § 19-301 of this article, a health  
 27 maintenance organization as defined in § 19-701(g) of this article, an outpatient clinic,  
 28 [and] a medical laboratory, A COMPREHENSIVE CRISIS RESPONSE CENTER, A CRISIS  
 29 STABILIZATION CENTER, AND A CRISIS TREATMENT CENTER ESTABLISHED UNDER §  
 30 7.5-207 OF THIS ARTICLE.

31 (2) “Health care provider” includes the agents, employees, officers, and  
 32 directors of a facility and the agents and employees of a health care provider.

33 7.5-207.

1           (a) Subject to subsection (b) of this section, the Administration shall establish  
2 crisis treatment centers that provide individuals who are in a mental health or substance  
3 use disorder crisis with access to clinical staff who:

4           (1) Perform assessments and level of care determinations 24 hours a day  
5 and 7 days a week; and

6           (2) Connect the individuals to care immediately.

7           (b) At least one crisis treatment center shall be established on or before June 1,  
8 2018.

9           (c) The Administration shall establish the crisis treatment centers required under  
10 subsection (a) of this section in a manner that is consistent with the strategic plan developed  
11 by the Behavioral Health Advisory Council, as required by Chapters 405 and 406 of the Acts  
12 of the General Assembly of 2016.

13           (d) On or before September 1, 2017, and on or before September 1 each year  
14 thereafter until the Administration establishes the crisis treatment centers required under  
15 subsection (a) of this section, the Administration shall submit, in accordance with § 2-1257  
16 of the State Government Article, a report on the status of the establishment of crisis treatment  
17 centers under this section to the Joint Committee on Behavioral Health and Opioid Use  
18 Disorders.

20           (A) At least once a year, the Department shall:

21           (1) Publish a list of emergency facilities and their addresses; and

22           (2) Give the list to each health department, judge of a court, sheriff's office,  
23 police station, **LOCAL BEHAVIORAL HEALTH AUTHORITY**, and Secret Service office in  
24 this State.

25           (B) **THE LIST PUBLISHED UNDER SUBSECTION (A)(1) OF THIS SECTION MAY**  
26 **INCLUDE:**

27           (1) **COMPREHENSIVE CRISIS RESPONSE CENTERS;**

28           (2) **CRISIS STABILIZATION CENTERS; ~~AND~~**

29           (3) **CRISIS TREATMENT CENTERS ESTABLISHED UNDER § 7.5-207 OF**  
30 **THIS ARTICLE; AND**

31           (4) **OUTPATIENT MENTAL HEALTH CLINICS.**

1        (C) BEFORE INCLUDING A FACILITY UNDER SUBSECTION (B) OF THIS  
2 SECTION IN THE LIST OF EMERGENCY FACILITIES, THE DEPARTMENT SHALL  
3 CONSULT WITH STAKEHOLDERS TO DEVELOP A MODEL PROGRAM STRUCTURE THAT  
4 ENSURES THAT A PROGRAM WISHING TO SERVE AS AN EMERGENCY FACILITY:

5            (1) IS ADEQUATELY STAFFED TO PROVIDE 24-HOUR EMERGENCY  
6 PETITION SERVICES;

7            (2) PROVIDES THE NECESSARY SERVICES REQUIRED FOR AN  
8 EMERGENCY PETITION;

9            (3) HAS WRITTEN PROCEDURES IN PLACE THAT PROVIDE FOR  
10 INVOLUNTARY ADMISSIONS, THROUGH AN EMERGENCY PETITION, INCLUDING TO A  
11 LICENSED HOSPITAL, AS NECESSARY;

12            (4) PROVIDES ADDITIONAL SUPPORT TO RESPECT THE DUE PROCESS  
13 RIGHTS OF PATIENTS RECEIVED THROUGH THE EMERGENCY PETITION PROCESS;  
14 AND

15            (5) COMPLIES WITH ADDITIONAL PROCEDURES AS OTHERWISE  
16 DETERMINED BY THE DEPARTMENT.

17        (D) ON OR BEFORE SEPTEMBER 30 EACH YEAR, THE DEPARTMENT SHALL  
18 REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE  
19 STATE GOVERNMENT ARTICLE, ON:

20            (1) THE NUMBER OF FACILITIES THAT HAVE SOUGHT TO BE  
21 DESIGNATED AN EMERGENCY FACILITY;

22            (2) THE NUMBER OF THE FACILITIES REPORTED UNDER ITEM (1) OF  
23 THIS SUBSECTION THAT HAVE ATTEMPTED TO MEET THE MODEL FACILITY  
24 STANDARDS DEVELOPED UNDER SUBSECTION (C) OF THIS SECTION;

25            (3) THE PROGRESS OF THE FACILITIES REPORTED UNDER ITEM (2) OF  
26 THIS SUBSECTION TOWARD MEETING THE MODEL FACILITY STANDARDS;

27            (4) THE DEVELOPMENT OF COLLABORATIVE MODELS BETWEEN  
28 STATE, LOCAL, AND PRIVATE ENTITIES; AND

29            (5) WHETHER THE DEPARTMENT, IN CONSULTATION WITH  
30 STAKEHOLDERS, HAS DETERMINED THAT ANY CHANGES TO THE MODEL FACILITY  
31 STANDARDS ARE NECESSARY.

1            SECTION 2. AND BE IT FURTHER ENACTED, That the Maryland Department of  
2 Health may not add emergency facilities to the list published under § 10-621(a)(1), as  
3 amended by Section 1 of this Act, of the Health – General Article until the model facility  
4 standards required under § 10-621(c) of the Health – General Article, as enacted by Section  
5 1 of this Act, have been developed.

6            SECTION ~~2.~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
7 October 1, 2020.
