SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

1 (1) is computed as a retirement allowance under § 27-402 of this article on 2 the basis of the former member's creditable service at the time of separation from 3 employment; and

4 (2) may be paid in one of the optional forms of allowances under § 21–403 5 of this article, if at retirement, the member does not have a spouse or child <u>WHO IS</u> under 6 the age of [18] **26** <u>OR IS DISABLED</u>.
