Department of General Services - Jurisdiction and Maryland Capitol Police

FOR the purpose of altering the jurisdiction of the Department of General Services to include State-owned or State-leased buildings and grounds and certain surrounding areas of those buildings and grounds; altering the jurisdiction of the Maryland Capitol Police of the Department; requiring the Secretary of General Services to appoint the Chief of the Maryland Capitol Police; providing that the Chief serves at the pleasure of the Secretary; requiring the Chief to supervise and direct the affairs and operations of the Maryland Capitol Police; repealing a certain provision of law providing that a member of the Maryland Capitol Police has the same powers as a sheriff or police officer only under certain circumstances; providing that a Maryland Capitol Police officer has all the powers granted to a peace officer and a police officer of the State; authorizing a Maryland Capitol Police officer to exercise certain powers provided the police officer meets certain legal requirements and is designated by the Department as a police officer; requiring the Secretary to appoint certain police employees; requiring the Secretary to make certain appointments from a list of eligible candidates in accordance with certain provisions of law; requiring that each police employee remains in a probationary status for a certain period of time; authorizing the Secretary to terminate the employment of a police employee in probationary status for any reason that the Secretary considers sufficient; repealing a certain provision of law providing that the Secretary has concurrent authority with certain chiefs of police to enforce certain laws in certain areas; and generally relating to the Department of General Services.
