A BILL ENTITLED

1 AN ACT concerning

Vehicle Laws – Registration Renewal – Inspection Requirement

3 FOR the purpose of requiring the Motor Vehicle Administration to require, if applicable, 4 the submission of a valid registration renewal inspection certificate before renewing $\mathbf{5}$ a motor vehicle registration; requiring every vehicle driven on the highways in the 6 State to have certain equipment meeting or exceeding certain standards; requiring 7 a registration renewal inspection to include a certain examination of certain motor 8 vehicle equipment; providing that a registration renewal inspection certificate shall 9 remain valid for a certain period of time; requiring a registration renewal inspection certificate to include certain information; prohibiting an inspection station from 10 11 charging more than a certain amount for conducting a registration renewal 12inspection; requiring the Administration to adopt regulations to implement this Act; 13 defining "registration renewal inspection certificate"; and generally relating to required vehicle inspections for motor vehicle registration renewal. 14

2 (a) (1) Except as provided in subsection (b) of this section, unless current 3 validation tabs have been issued by the Administration and are displayed on the plates as 4 provided in this subtitle, the registration and the registration plates issued under this title 5 for them expire at midnight on the dates indicated on the registration card issued by the 6 Administration.

7 (2) IF REQUIRED UNDER § 23–107.1 OF THIS ARTICLE, THE 8 ADMINISTRATION SHALL REQUIRE THE SUBMISSION OF A VALID REGISTRATION 9 RENEWAL INSPECTION CERTIFICATE BEFORE RENEWING THE REGISTRATION FOR A 10 MOTOR VEHICLE.

12Every vehicle driven on the highways in this State shall, where applicable, (a) 13have the following equipment, meeting or exceeding the standards established jointly by 14the Administration and the Division: brakes, steering, suspension, horn, door handles, mirrors, tires, exhaust system, lights, glazing, WINDOWS, WINDSHIELD, windshield 1516wipers, odometer, speedometer, bumpers, properly aligned wheels, wheels and wheel lugs, 17fenders, floor pans, hood, hood catches, emissions equipment, fuel system, front seat, motor 18mounts, gear selection indicator for automatic transmissions, universal joints, and seat 19 belts or combination seat belt-shoulder harness if required as original equipment under § 2022–412 or § 22–412.1 of this article.

21 (b) (1) The Administration and the Division jointly may establish standards 22 by rule or regulation for this equipment.

23 (2) The Administration and the Division shall adopt, consistent with 24 federal law, regulations establishing equipment, performance, and other technical 25 standards for:

- 26 (i) Autocycles; and
- 27 (ii) Low speed vehicles.

(A) IN THIS SECTION, "REGISTRATION RENEWAL INSPECTION
 CERTIFICATE" MEANS A CERTIFICATION BY AN AUTHORIZED INSPECTION STATION
 THAT A MOTOR VEHICLE MEETS OR EXCEEDS THE STANDARDS ESTABLISHED UNDER
 THIS TITLE FOR THE EQUIPMENT SUBJECT TO INSPECTION.

33 (B) THIS SECTION DOES NOT APPLY TO CLASS L (HISTORIC) VEHICLES.

1 (C) BEFORE THE ADMINISTRATION RENEWS THE REGISTRATION OF A 2 MOTOR VEHICLE THAT IS AT LEAST 5 MODEL YEARS OLD, THE ADMINISTRATION 3 SHALL REQUIRE THE SUBMISSION OF A VALID REGISTRATION RENEWAL INSPECTION 4 CERTIFICATE FOR THE MOTOR VEHICLE IN THE MANNER THE ADMINISTRATION 5 REQUIRES.

6 (D) A REGISTRATION RENEWAL INSPECTION SHALL INCLUDE AN 7 EXAMINATION OF THE FOLLOWING EQUIPMENT TO DETERMINE IF THE EQUIPMENT 8 MEETS OR EXCEEDS THE STANDARDS ESTABLISHED UNDER THIS TITLE:

- 9 (1) BRAKES;
- 10 (2) STEERING COLUMN;
- 11 (3) HORN;
- 12 (4) MIRRORS;
- 13 **(5)** LIGHTS;
- 14 **(6)** WINDOWS;
- 15 **(7) WINDSHIELD;**
- 16 (8) WINDSHIELD WIPERS;
- 17 (9) SPEEDOMETER; AND
- 18 **(10) SEAT BELTS.**
- 19 (E) A REGISTRATION RENEWAL INSPECTION CERTIFICATE SHALL:
- 20(1)REMAIN VALID FOR 90 DAYS AFTER THE DATE THE CERTIFICATE21IS ISSUED; AND
- 22 (2) **IDENTIFY:**

23(I)THE INSPECTION STATION WHERE THE MOTOR VEHICLE24WAS INSPECTED; AND

25(II)THE LICENSED INSPECTION MECHANIC WHO INSPECTED26THE MOTOR VEHICLE.

1 (F) AN INSPECTION STATION MAY NOT CHARGE MORE THAN \$45 FOR 2 CONDUCTING A REGISTRATION RENEWAL INSPECTION.

3 (G) THE ADMINISTRATION SHALL ADOPT REGULATIONS TO IMPLEMENT 4 THIS SECTION.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2020.
