1 AN ACT concerning

Real Property – Notice of Easements, Covenants, Restrictions, and Conditions – Recordation

FOR the purpose of authorizing notice of certain easements, covenants, restrictions, and
conditions to be recorded in the land records of the county in which the property
interest is located; specifying the information required to be provided in the notice;
requiring that the notice be indexed for recording in a certain manner; providing that
failure to record a notice in accordance with this Act does not impair the rights or
interests of the holder of an easement, a covenant, a restriction, or a condition; and
generally relating to easements, covenants, restrictions, and conditions.
