 9 Maryland Efficient Grant Application Council in accordance with § 2-210(b)(1)(iii) of the
 10 State Finance and Procurement Article, as enacted by Section 1 of this Act; and

11 (2) on or before December 31 of the calendar years 2022 through 2026,
 12 report to the General Assembly on the progress of the implementation of this Act, including
 13 any recommendations of the Maryland Efficient Grant Application Council.

14 SECTION ~~4~~ 3. AND BE IT FURTHER ENACTED, That the terms of the initial
 15 members appointed to the Maryland Efficient Grant Application Council by the Governor
 16 shall expire as follows:

17 (1) two members in 2022; and
