2 SECTION 2. AND BE IT FURTHER ENACTED, That the Drafter's Notes contained  
3 in this Act are not law and may not be considered to have been enacted as part of this Act.

4 SECTION 3. AND BE IT FURTHER ENACTED, That the provisions of this Act are  
5 intended solely to correct technical errors in the law and there is no intent to revive or  
6 otherwise affect law that is the subject of other acts, whether those acts were signed by the  
7 Governor prior to or after the signing of this Act.

8 SECTION 4. AND BE IT FURTHER ENACTED, That the publishers of the  
9 Annotated Code of Maryland, subject to the approval of the Department of Legislative  
10 Services, shall make any changes in the text of the Annotated Code necessary to effectuate
