Workers' Compensation - Hernia Claims

- FOR the purpose of altering the time period within which a covered employee must report to the employer a hernia caused by an accidental personal injury or by a strain arising out of and in the course of employment for the purpose of filing a claim for compensation; authorizing a covered employee to file a claim for compensation for a hernia caused by an accidental personal injury within a certain time period under certain circumstances; making conforming changes; providing for the application of this Act; and generally relating to workers' compensation and hernia claims.

17 18 19	(3) Notwithstanding paragraphs (1) and (2) of this subsection, if a covered employee fails to file a claim within 2 years after the date of the accidental personal injury, the claim is completely barred.
20 21 22	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any claim arising from events occurring before the effective date of this Act.
23 24	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2020.
