18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19	That the Laws of Maryland read as follows:

22	(a) In this subtitle the following words have the meanings indicated.
23	(c) "Council" means the Tri–County Council for Southern Maryland.

- 2 (a) The State and Calvert, Charles, and St. Mary's counties may jointly finance 3 the Council and its activities.
- 4 (b) (1) The State may provide financial support to the Council to assist in 5 carrying out the activities of the Council.
- 6 (2) (i) On or before August 1 of each year, the Council shall submit its 7 proposed work programs and operating budget for the following fiscal year to the 8 Department.
- 9 (ii) The submission shall include supporting schedules to show how 10 the budget is financed, and to provide for review and recommendations.
- 11 (iii) After review, the Department shall forward the submission and any recommendations to the Department of Budget and Management for consideration.
- 13 (3) The Governor shall include in the State budget for the following fiscal 14 year an appropriation to partially support the Council.
- 15 (c) (1) The county commissioners of Calvert, Charles, and St. Mary's counties 16 shall appropriate money each year for the Council to foster cooperative planning and 17 development in the region as follows:
- 18 (i) Calvert County [\$7,000] **\$125,000**;
- 19 (ii) Charles County [\$9,000] **\$125,000**; and
- 20 (iii) St. Mary's County [\$9,000] **\$125,000**.
- 21 (2) Calvert, Charles, and St. Mary's counties may appropriate any other 22 money for the Council as they consider necessary and appropriate.
- 23 (d) The Council may accept additional money from any other public or private 24 source.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020.
