17 18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 24 THE U.S. DEPARTMENT OF AGRICULTURE FOR COMPLIANCE WITH § 12(L) OF THE
- 25 RICHARD B. RUSSELL NATIONAL SCHOOL LUNCH ACT.
- 26 (D) If A WAIVER REQUESTED IN ACCORDANCE WITH THIS SECTION WAS
- 27 GRANTED AND LATER LAPSES OR IS TERMINATED, THE DEPARTMENT SHALL APPLY
- 28 TO RENEW THE WAIVER.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
- 30 measure, is necessary for the immediate preservation of the public health or safety, has
- been passed by a yea and nay vote supported by three-fifths of all the members elected to
- 32 each of the two Houses of the General Assembly, and shall take effect from the date it is
- 33 enacted.
