Labor and Employment – Health Care Facilities – Workplace Safety (Safe Care Act)

FOR the purpose of altering the composition of a certain workplace safety committee; requiring State residential centers and State-operated hospitals to develop a workplace safety plan; establishing certain requirements for a certain workplace safety plan; requiring that certain training address certain risks and include certain instruction on certain matters; requiring certain State residential centers and State-operated hospitals to collaborate with a certain committee for certain purposes; requiring that certain procedures include certain other procedures; requiring State residential centers and State-operated hospitals to ensure that a certain workplace safety plan is implemented in a certain manner, coordinate certain activities with certain health care works, implement certain measures, encourage certain workers to take certain actions, and report to the Commissioner of Labor and Industry certain incidents of workplace violence; prohibiting State residential centers and State-operated hospitals from taking certain actions against a health care worker for participating in a workplace safety plan; requiring State residential centers and State-operated hospitals to maintain and make available certain information to the Commissioner on request; prohibiting certain information from containing certain personal information; requiring the Commissioner to adopt certain regulations; requiring certain health care facilities to submit a certain annual summary to the Commissioner; requiring the Commissioner to make available online certain summaries; defining certain terms; and generally relating to workplace safety in health care facilities.
