1 AN ACT concerning

Housing and Community Development – Neighborhood Revitalization – Passive House Pilot Program

4 FOR the purpose of establishing the Passive House Pilot Program in the Department of $\mathbf{5}$ Housing and Community Development: establishing the purposes of the Program; 6 requiring the Department to solicit proposals from nonprofit organizations that 7 feature certain elements; requiring the Department to give priority to proposals for 8 which a nonprofit organization partners with certain educational institutions; 9 establishing the Passive House Pilot Program Fund as a special, nonlapsing fund; 10 specifying the purpose of the Fund; requiring the Secretary of Housing and 11 Community Development or the Secretary's designee to administer the Fund; 12 requiring the State Treasurer to hold the Fund and the Comptroller to account for 13the Fund; specifying the contents of the Fund; requiring the Governor, for certain fiscal years, to include a certain appropriation in the annual budget bill for the Fund; 14 providing for the investment of money in and expenditures from the Fund; requiring 15interest earnings of the Fund to be credited to the Fund; providing that certain 16 17appropriations and expenditures are subject to audit by the Office of Legislative 18 Audits: exempting the Fund from a certain provision of law requiring interest 19 earnings on State money to accrue to the General Fund of the State; requiring the 20Department to adopt certain regulations; defining certain terms; providing for the 21termination of this Act; and generally relating to the Passive House Pilot Program.

12 (A) THERE IS A PASSIVE HOUSE PILOT PROGRAM IN THE DEPARTMENT.

13 (B) THE DEPARTMENT SHALL ADMINISTER THE PROGRAM.

14 (C) THE PURPOSE OF THE PROGRAM IS TO ASSIST A NONPROFIT 15 ORGANIZATION IN PARTNERSHIP WITH NEIGHBORING HIGH SCHOOLS AND 16 INSTITUTES OF HIGHER EDUCATION, TO PROVIDE STUDENTS WITH CAREER AND 17 TECHNICAL EDUCATIONAL EXPERIENCES THROUGH THE RENOVATION OF 18 RESIDENTIAL PROPERTIES TO BECOME PASSIVE HOUSES.

20 (A) THE DEPARTMENT SHALL SOLICIT PROPOSALS FROM NONPROFIT 21 ORGANIZATIONS FOR THE PROGRAM THAT FEATURE:

(1) THE ACQUISITION OF ONE OR MORE PROPERTIES FOR
 RENOVATION THAT ARE WITHIN CLOSE PROXIMITY OF A HIGH SCHOOL LOCATED IN
 BALTIMORE CITY;

25 (2) RENOVATION OF THE ACQUIRED PROPERTY OR PROPERTIES BY:

26 (I) USING COMPONENTS CERTIFIED BY THE PASSIVE HOUSE 27 INSTITUTE; AND

16 **(B)** THE PURPOSE OF THE FUND IS TO COVER THE FOLLOWING COSTS OF 17 THE PROGRAM:

18 (1) **PROPERTY ACQUISITION COSTS;**

19 (2) **PROPERTY RENOVATION COSTS, INCLUDING:**

25 (C) THE SECRETARY OR THE SECRETARY'S DESIGNEE SHALL ADMINISTER 26 THE FUND IN ACCORDANCE WITH THIS SUBTITLE AND ANY OTHER APPLICABLE LAW.

27 (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 28 SUBJECT TO REVERSION UNDER § 7–302 OF THE STATE FINANCE AND 29 PROCUREMENT ARTICLE.

1 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 2 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

- 3 (E) THE FUND CONSISTS OF:
- 4 (1) APPROPRIATIONS AS PROVIDED IN THE STATE BUDGET;
- 5 (2) ANY INTEREST EARNINGS OF THE FUND; AND

6 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR 7 THE BENEFIT OF THE PROGRAM.

8 (F) THE FUND MAY BE USED ONLY FOR THE PURPOSES DESCRIBED UNDER 9 SUBSECTION (B) OF THIS SECTION.

10 (G) FOR EACH OF THE FOLLOWING FISCAL YEARS, THE GOVERNOR SHALL 11 INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE FUND IN AN 12 AMOUNT EQUAL TO:

- 13 (1) FOR FISCAL YEAR 2022, \$300,000;
- 14 (2) FOR FISCAL YEAR 2023, \$400,000; AND
- 15 (3) FOR FISCAL YEAR 2024, \$300,000.

16 (H) (G) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE 17 FUND IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

18(2)ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED19TO THE FUND.

20 (H) (H) THE FUND IS SUBJECT TO AUDIT BY THE OFFICE OF LEGISLATIVE 21 AUDITS AS PROVIDED IN § 2–1220 OF THE STATE GOVERNMENT ARTICLE.

27 (a) (2) (i) Notwithstanding any other provision of law, and unless 28 inconsistent with a federal law, grant agreement, or other federal requirement or with the

terms of a gift or settlement agreement, net interest on all State money allocated by the 1 $\mathbf{2}$ State Treasurer under this section to special funds or accounts, and otherwise entitled to 3 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General 4 Fund of the State. The provisions of subparagraph (i) of this paragraph do not apply $\mathbf{5}$ (ii) 6 to the followings funds: 7121. the Markell Hendricks Youth Crime Prevention and 8 Diversion Parole Fund; [and] 9 122.the Federal Government Shutdown Employee Assistance 10 Loan Fund; AND THE PASSIVE HOUSE PILOT PROGRAM FUND. 123. 11 12SECTION 2.
