CHAPTER _____

1 AN ACT concerning

2 **Carroll County – Contracts and Purchases**

3 FOR the purpose of increasing to a certain amount the cost of a public work or improvement
4 or the purchase price of supplies or equipment for which the County Commissioners
5 of Carroll County may enter into a contract; requiring that when the cost of a public
6 work or improvement or the purchase price of supplies or equipment in Carroll
7 County exceeds a certain amount under certain conditions, the Chief of the Bureau
8 of Purchasing for the County Commissioners shall advertise for bids for a certain
9 amount of time in a media accessible to the general public; requiring the County
10 Commissioners to publish on the County government website certain notice of the
11 award of a certain procurement contract; and generally relating to contracts and
12 purchases in Carroll County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article 7 – Carroll County**

1 (a) In contracting for any necessary public work or improvement or for the
2 purchase of supplies and equipment needed at any time by the several departments of the
3 County, the County Commissioners of Carroll County may enter into contracts for public
4 work or improvement and may purchase supplies and equipment on an order passed by the
5 County Commissioners provided that the cost of the public work or improvement or the
6 purchase price of the supplies and equipment does not exceed ~~[\$25,000.00]~~ **\$35,000.00**.

7 (b) When the cost of any project for public work or improvement, or the purchase
8 price of any supplies and equipment exceeds ~~[\$25,000.00]~~ **\$35,000.00**, except in
9 emergencies or when there is a sole source of supply, the Chief of the Bureau of Purchasing
10 for the County Commissioner shall provide public notice for at least one week in a media
11 accessible to the general public including, but not limited to a newspaper circulated in
12 Carroll County and an internet web site, for bids to perform the public work or
13 improvement or to furnish the supplies and equipment. The public notice shall state the
14 date, time and place of opening of the bids.

15 (c) The bids shall be opened in the presence of an employee designated by the
16 County Commissioners of Carroll County.

17 (d) The County Commissioners of Carroll County shall award the contract to the
18 lowest responsible bidder whose bid is considered reasonable, or in their discretion, may
19 reject any and all bids.

20 (e) The County Commissioners may authorize nonprofit entities that are funded
21 by the County or eligible to receive county funds, to participate in county procurement
22 contracts.

23 (f) The County Commissioners may authorize the Chief of the Bureau of
24 Purchasing to participate in cooperative or piggyback purchasing with other governmental
25 agencies or associations, provided the public notice for the bid is in accordance with the
26 rules and regulations governing the soliciting agency or association.

27 **(G) THE COUNTY COMMISSIONERS SHALL PUBLISH ON THE COUNTY**
28 **GOVERNMENT WEBSITE NOTICE OF THE AWARD OF A PROCUREMENT CONTRACT**
29 **ENTERED INTO UNDER SUBSECTION (B) OF THIS SECTION, INCLUDING THE DOLLAR**
30 **VALUE OF THE CONTRACT AWARDED.**

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
32 October 1, 2020.
