#### AMENDMENT NO. 1

On page 1, in line 2, before "Venison" insert "Income Tax Credit for"; in line 3, strike "Income Tax Credit and Grant Program" and substitute "Alterations, **Extension, and Testing for Chronic Wasting Disease**"; in line 6, strike "an antlerless" and substitute "<u>a</u>"; in line 8, strike "an" and substitute "<u>a</u>"; in line 9, strike "antlerless"; strike beginning with "<u>establishing</u>" in line 10 down through "<u>term:</u>" in line 15 and substitute "altering the maximum amount of qualified expenses an individual may claim as a credit against the State income tax for a certain donation of a deer carcass or processed deer meat; altering the maximum aggregate credit amount the individual may claim in a taxable year; extending the termination date of the tax credit; requiring the Department of Natural Resources to report to certain committees of the General Assembly on or before a certain date on certain testing;"; in line 16, strike "and termination"; strike beginning with "<u>providing</u>" in line 16 down through "<u>Act;</u>" in line 17; in line 18, strike "antlerless"; and strike beginning with "<u>and</u>" in line 18 down through "<u>Program</u>" in line 19 and substitute "<u>and testing for chronic wasting disease</u>".

On page 2, strike in their entirety lines 2 through 11, inclusive, and substitute:

"<u>BY repealing and reenacting, with amendments,</u> <u>Chapter 172 of the Acts of the General Assembly of 2018</u> <u>Section 3</u>

<u>BY repealing and reenacting, with amendments,</u> <u>Chapter 173 of the Acts of the General Assembly of 2018</u> <u>Section 3</u>";

and strike beginning with "FOR" in line 22 down through the second comma in line 23.

SECTION 3. AND BE IT FURTHER ENACTED, That, on or before December 31, 2021, the Department of Natural Resources shall report to the Senate Education, Health, and Environmental Affairs Committee and the House Environment and

<u>Transportation Committee, in accordance with § 2–1257 of the State Government</u> <u>Article, on the testing of deer brought to deer processors for chronic wasting disease.</u>

<u>SECTION 4. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall</u> <u>be applicable to all taxable years beginning after December 31, 2020.</u>

SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2021.".
