AMENDMENTS TO SENATE BILL 427  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, after “public” insert “middle and high”; in line 6, after “dates;” insert “requiring the State to reimburse each county board for certain costs; requiring each county board to submit to the State Department of Education a request for reimbursement for certain costs on or before certain dates; requiring the Governor to include a certain appropriation in the annual budget bill in a certain fiscal year;”; in line 7, after “requiring” insert “each school nurse at”; in the same line, strike “install” and substitute “make available to students”; and strike beginning with “product” in line 7 down through “restroom” in line 8 and substitute “products”.

AMENDMENT NO. 2

On page 1, in line 22, after “(B)” insert “(1)”; in the same line, strike “SUBSECTION (C) OF THIS SECTION” and substitute “PARAGRAPH (2) OF THIS SUBSECTION”; and in line 23, after “PUBLIC” insert “MIDDLE AND HIGH”.

On page 2, in line 2, strike “(C) (1)” and substitute “(2)”; in line 4, after “TWO” insert “WOMEN’S”; in line 5, strike “2021” and substitute “2022”; strike beginning with the colon in line 6 down through “ALL” in line 9 and substitute “, ALL”; strike beginning with the semicolon in line 9 down through “RESTROOMS” in line 11; after line 11, insert:

“(3) (1) THE STATE SHALL REIMBURSE A COUNTY BOARD FOR THE COSTS OF PURCHASING AND INSTALLING MENSTRUAL HYGIENE PRODUCT DISPENSERS TO COMPLY WITH THE REQUIREMENTS OF PARAGRAPH (2) OF THIS SUBSECTION.

(II) EACH COUNTY BOARD SHALL SUBMIT TO THE DEPARTMENT A REQUEST FOR REIMBURSEMENT FOR THE COSTS OF PURCHASING AND INSTALLING MENSTRUAL HYGIENE PRODUCT DISPENSERS TO COMPLY WITH THE REQUIREMENTS OF:

1. PARAGRAPH (2)(I) OF THIS SUBSECTION, ON OR BEFORE NOVEMBER 1, 2022; AND

2. PARAGRAPH (2)(II) OF THIS SUBSECTION, ON OR BEFORE SEPTEMBER 1, 2025.

(III) FOR FISCAL YEAR 2023, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$325,000 TO BE USED TO REIMBURSE EACH COUNTY BOARD FOR THE COSTS REPORTED TO THE DEPARTMENT UNDER SUBPARAGRAPH (II)1 OF THIS PARAGRAPH.”;

in line 12, strike “(2)” and substitute “(C)”; in the same line, strike “A” and substitute “EACH SCHOOL NURSE AT A”; in the same line, strike “INSTALL” and substitute “MAKE AVAILABLE, AT NO CHARGE TO STUDENTS,”; and in line 13, strike “PRODUCT DISPENSERS IN AT LEAST ONE RESTROOM” and substitute “PRODUCTS”.
