## A BILL ENTITLED

1 AN ACT concerning

## Task Force on Higher Education Students With Chronic Health Conditions

- 3 FOR the purpose of establishing the Task Force on Higher Education Students With 4 Chronic Health Conditions; providing for the composition, chair, and staffing of the 5 Task Force; prohibiting a member from receiving certain compensation, but 6 authorizing the reimbursement of certain expenses; requiring the Task Force to 7 obtain data on, study, and make recommendations regarding certain matters; 8 authorizing the Task Force to use certain resources to carry out its duties; requiring 9 the Task Force to report its findings and recommendations to the Governor and the 10 General Assembly on or before a certain date; requiring the Maryland Department 11 of Health and the Maryland Higher Education Commission to make the report to the Governor and the General Assembly available to the public; providing for the 12 termination of this Act; and generally relating to the Task Force on Higher Education 13 Students With Chronic Health Conditions. 14
- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 16 That:
- 17 (a) There is a Task Force on Higher Education Students With Chronic Health Conditions.
- 19 (b) The Maryland Department of Health jointly with the Maryland Higher 20 Education Commission shall appoint members of the Task Force, including members that 21 are:

23 24 25 26	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2021. It shall remain effective for a period of 2 years and, at the end of June 30, 2023, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
