University System of Maryland, Morgan State University, and St. Mary's College
of Maryland – Board Membership – Alterations

4 FOR the purpose of altering the membership of the Board of Regents of the University 5 System of Maryland to increase the number of members, require that certain 6 members have backgrounds in certain activities, and require that certain members 7 attended certain institutions of higher education; altering the membership of the 8 Board of Regents of Morgan State University and the Board of Trustees of St. Mary's 9 College of Maryland to increase the number of members and require that certain 10 members have backgrounds in certain activities; providing for the initial 11 appointment of certain members of the Board of Regents of Morgan State University 12 and the Board of Trustees of St. Mary's College of Maryland; and generally relating 13 to the membership of the Board of Regents of the University System of Maryland, 14 the Board of Regents of Morgan State University, and the Board of Trustees of St. 15 Mary's College of Maryland.

Article - Education 1 2 12-102.3 The government of the University System of Maryland is vested in the Board (b) of Regents of the University System of Maryland. 4 5 (c) The Board of Regents consists of [21] 28 members as follows: 6 (1) (i) Except as provided in item (ii) of this item, two members shall be 7 full-time students in good academic standing at an institution under the jurisdiction of the 8 Board: and 9 A student member who is in good academic standing at the (ii) 10 University of Maryland Global Campus shall be exempt from the full-time student 11 requirement in item (i) of this item; 12 (2)One member shall be the Secretary of Agriculture ex officio; 13 (3) One member shall be the Secretary of Commerce ex officio; One member shall be appointed by the President of the Senate; 14 **(4)** 15 One member shall be appointed by the Speaker of the House; and (5)16 (6)The remaining members of the Board shall be residents of the State, shall be appointed from the general public, and shall include: 17 One individual with a background in higher education 18 (i) 19 administration: 20 One individual with a background in finance; [and] (ii) 21 (iii) One individual with a background in diversity and workplace 22 inclusion; 23 TWO INDIVIDUALS WITH A BACKGROUND IN LABOR UNION (IV) 24**ORGANIZING**; 25**(**V**)** ONE INDIVIDUAL WITH A BACKGROUND IN IMMIGRATION 26ADVOCACY; 27 (VI) ONE INDIVIDUAL WITH A BACKGROUND IN CIVIL RIGHTS 28 ADVOCACY;

7 8 9	(d) In making appointments to the Board, the Governor, the President of the Senate, and the Speaker of the House shall consider representation from all parts of the State.
10 11	(e) (1) Each member of the Board appointed under subsection (c)(1) and (6) of this section shall be appointed by the Governor, with the advice and consent of the Senate.
12 13 14	(2) After the 40th day, and before the 80th day, from the commencement of each regular session of the General Assembly, the Senate shall consider each year's appointees to the Board collectively to ensure adequate balance of membership.
15 16 17	(f) (1) Except for the student members, each appointed member serves for a term of 5 years from July 1 of the year of appointment and until a successor is appointed and qualifies. These members may be reappointed.
18 19 20	(2) The student members shall be appointed for a term of 2 years, from July 1, and may be reappointed if the student remains a student at any campus of the University System of Maryland.
21 22	(3) A member appointed to fill a vacancy in an unexpired term serves only for the remainder of that term and until a successor is appointed and qualifies.

25 26	(b) The Board of Regents consists of [15] 19 members appointed by the Governor with the advice and consent of the Senate.
27 28	(c) (1) (I) One member of the Board of Regents shall be a student in good academic standing at the University who:

- 1 The student member serves for a term of 1 year and until a [(2)] (II) 2 successor is appointed and qualifies. 3 (III) The student may be a resident of a state other than Maryland, 4 but the residency status of the student may not be considered in determining the number of resident or nonresident regents as provided for in subsection (d)(2) of this section. 5 6 **(2)** THE REMAINING MEMBERS OF THE BOARD OF REGENTS SHALL 7 **INCLUDE: (I)** 8 TWO INDIVIDUALS WITH A BACKGROUND IN LABOR UNION 9 **ORGANIZING**; 10 (II) ONE INDIVIDUAL WITH A BACKGROUND IN IMMIGRATION 11 ADVOCACY; AND 12 (III)ONE INDIVIDUAL WITH A BACKGROUND IN CIVIL RIGHTS 13 ADVOCACY. 14 14–402. 11 12	(b) The members appointed in accordance with this section shall serve for a term of 5 years beginning July 1, 2022, until a successor is appointed and qualifies.
13	SECTION 3. AND BE IT FURTHER ENACTED, That:
14 15 16	(a) The Governor shall appoint the following members to the Board of Trustees of St. Mary's College of Maryland in accordance with § 14–402 of the Education Article, as enacted by Section 1 of this Act:

19	(3) one individual with a background in civil rights advocacy.
20 21	(b) The members appointed in accordance with this section shall serve for a term of 6 years beginning July 1, 2022, until a successor is appointed and qualifies.
