BY repealing and reenacting, with amendments, Article – Real Property Section 14–125 Annotated Code of Maryland (2015 Replacement Volume and 2020 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Real Property 14-125. (a) (1) In this section the following words have the meanings indicated.
