Harford County - Alcoholic Beverages - Resort Complex License

- 3 FOR the purpose of establishing in Harford County a resort complex license; authorizing 4 the Board of License Commissioners for Harford County to issue one resort complex 5 license to a certain person; specifying that the license authorizes the holder to sell 6 beer, wine, and liquor at certain outlets in the resort complex; establishing the days 7 and times during which a license holder may serve alcoholic beverages; exempting 8 the resort complex license from a certain license quota or restriction; establishing 9 that certain areas in a resort complex may be excluded from the licensed premises; 10 providing that a resort complex for which the license is issued is subject to certain 11 alcohol awareness training requirements; establishing certain license fees; defining a certain term; and generally relating to alcoholic beverages licenses in Harford 12 13 County.

- 25 That the Laws of Maryland read as follows:

- 5 $\,$ CONTIGUOUS PARCELS OF LAND:

- 7 (2) UNDER COMMON OWNERSHIP; AND
- 8 (3) WITH FACILITIES THAT:
- 9 (I) INCLUDE LODGING, CONFERENCE SPACES, MEETING
- 10 SPACES, ACTIVE OUTDOOR OPEN SPACES, WATERFRONT BEACH ACTIVITIES, OR A

- 18 (D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,

- 4 (5) ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR
- 5 OFF-PREMISES CONSUMPTION.
- 6 (E) A LICENSE HOLDER MAY SERVE ALCOHOLIC BEVERAGES:
- 7 (1) AT ONE OR MORE OUTSIDE OUTLETS IN THE RESORT COMPLEX ON
- 8 MONDAY THROUGH SUNDAY, FROM 6 A.M. TO MIDNIGHT;
- 9 (2) AT ONE OR MORE INSIDE OUTLETS IN THE RESORT COMPLEX:
- 10 (I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.
- 11 THE FOLLOWING DAY; AND
- 12 (II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT; AND
- 13 (3) AT ONE DESIGNATED OUTLET FOR OFF-PREMISES CONSUMPTION:
- 14 (I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.
- 15 THE FOLLOWING DAY; AND
- 16 (II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT.
- 17 (F) A RESORT COMPLEX LICENSE IS EXEMPT FROM ANY QUOTA OR
- 18 RESTRICTION ON OFF-SALE LICENSES ISSUED FOR THE ELECTION DISTRICT IN
- 19 WHICH THE RESORT COMPLEX IS LOCATED.
- 20 (G) (1) CERTAIN AREAS IN A RESORT COMPLEX MAY BE EXCLUDED FROM
- 21 THE PORTION OF THE PROPERTY THAT IS CONSIDERED TO BE THE LICENSED
- 22 PREMISES.
- 23 (2) A PERSON OTHER THAN THE RESORT COMPLEX LICENSE HOLDER
- 24 MAY OBTAIN A DIFFERENT CLASS OF LICENSE FOR AN AREA EXCLUDED UNDER
- 25 PARAGRAPH (1) OF THIS SUBSECTION.
- 26 (H) A RESORT COMPLEX FOR WHICH THE LICENSE IS ISSUED IS SUBJECT TO
- 27 THE ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4–505 OF THIS

- 29 (I) (1) THE INITIAL LICENSE FEE IS \$3,500.

- 1 (2) BEGINNING MAY 1, 2022, THE ANNUAL LICENSE FEE IS \$6,000.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 3 $\,$ 1, 2021.
