CHAPTER _____

1 AN ACT concerning

2 **Election Law – Party and Elected Public Offices – Prohibitions**

3 FOR the purpose of providing that certain provisions of law do not apply to certain
4 individuals; prohibiting individuals from simultaneously being a candidate for a
5 party office and an elected public office; prohibiting individuals from simultaneously
6 holding a party office and an elected public office; making clarifying changes; and
7 generally relating to simultaneous candidacy for and incumbency in more than one
8 office.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Election Law**

17 5–204.

18 **(A) THIS SECTION DOES NOT APPLY TO AN INDIVIDUAL WHO**
19 **SIMULTANEOUSLY HOLDS AN ELECTED PUBLIC OFFICE AND;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **(1)** IS ON THE BALLOT FOR THE NATIONAL PRESIDENTIAL
2 NOMINATING CONVENTION; **OR**

3 **(2)** HOLDS THE OFFICE OF DELEGATE TO THE NATIONAL
4 PRESIDENTIAL NOMINATING CONVENTION.

5 **[(a)] (B)** An individual simultaneously may not be a candidate for more than one
6 **ELECTED** public office.

7 **[(b)] (C)** An individual simultaneously may not be a candidate for more than one
8 office of a political party.

9 **[(c)] (D)** [Unless otherwise prohibited by rule of the applicable political party,
10 an] **AN** individual simultaneously may **NOT** be a candidate for a party office and **[a] AN**
11 **ELECTED** public office.

12 **(E)** **AN INDIVIDUAL SIMULTANEOUSLY MAY NOT HOLD A PARTY OFFICE AND**
13 **AN ELECTED PUBLIC OFFICE.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2021.
