### 1 AN ACT concerning

## Maryland Longitudinal Data System – Student Data – Pregnant and Parenting Students

# FOR the purpose of including data on pregnant and parenting students in the data collected, organized, managed, disaggregated, reported on, and analyzed by the Maryland Longitudinal Data System Center; altering the types of records excluded from the definition of "student data" for purposes of the Maryland Longitudinal Data System; and generally relating to the Maryland Longitudinal Data System.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 19 (b) "Center" means the Maryland Longitudinal Data System Center.

20 (c) "De-identified data" means a data set in which parent and student identity 21 information, including the State Assigned Student Identifier and student Social Security 22 number, has been removed.

- 21 (viii) Demographic data;
- 22 (ix) Juvenile delinquency records; [and]
- 23 (x) Elementary and secondary school disciplinary records; AND
