Solid Waste Management – Prohibition on Releasing a Balloon Into the Atmosphere

4 FOR the purpose of prohibiting a person from knowingly and intentionally releasing or 5 causing to be released, or organizing the release of, a certain balloon into the 6 atmosphere; requiring the Department of the Environment to enforce this Act; 7 authorizing the Department to delegate certain enforcement authority to a certain 8 unit, officer, or official of a local government; requiring a certain unit, officer, or 9 official of a local government with delegated enforcement authority to report certain 10 violations to the Department; establishing a civil penalty for a violation of this Act; 11 defining certain terms; providing for the application of this Act; and generally 12 relating to a prohibition on releasing a balloon into the atmosphere.
