A BILL ENTITLED

1 AN ACT concerning

2 **Minority Participation in the Alcoholic Beverages Industry – Study**

3 FOR the purpose of requiring the Governor’s Office of Small, Minority, and Women
4 Business Affairs to conduct a certain study concerning the alcoholic beverages
5 industry in the State; providing for the matters to be included in the study; requiring
6 the Governors’ Office of Small, Minority, and Women Business Affairs to conduct the
7 study in consultation and cooperation with certain agencies and interests; requiring
8 the Office of the Attorney General and the Department of Transportation to provide
9 staff for the study; requiring the Governor’s Office of Small, Minority, and Women
10 Business Affairs to report its findings and recommendations to the Governor and the
11 General Assembly on or before a certain date; providing for the termination of this
12 Act; and generally relating to the alcoholic beverages industry and minority
13 communities.

14 Preamble

15 WHEREAS, Since the end of Prohibition in 1933, the alcoholic beverages industry
16 has been dominated by a small number of companies, particularly in the area of distilled
17 spirits; and

18 WHEREAS, Although minorities, particularly Black Americans, constitute a
19 considerable portion of the consumers of alcoholic beverages, they are underrepresented in
20 the alcoholic beverages industry as manufacturers, distributors, and retailers; and

21 WHEREAS, Because of the sensitivity to community values and concerns that
22 belonging to a minority community brings to economic activity in the community,
23 meaningful participation by minorities in the alcoholic beverages industry, particularly in
24 the distribution and retail sectors, may provide a substantial benefit to minority
25 communities and to the State at large; and

26 WHEREAS, Under federal precedent, state–encouraged participation in an industry

1 through a set-aside or preference system requires demonstration of a disparity in the
2 industry based on historical discrimination; now, therefore,

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That:

5 (a) The Governor's Office of Small, Minority, and Women Business Affairs shall
6 conduct a study of the participation of minority-owned businesses in the alcoholic
7 beverages industry in the State.

8 (b) The study shall include:

9 (1) historical and current levels of participation by minority-owned
10 businesses in the manufacturing, distributing, and retail sales tiers of the alcoholic
11 beverages industry in the State;

12 (2) historical and current levels of market activity in retail sales of
13 alcoholic beverages in the State, especially in areas with high concentrations of minority
14 population;

15 (3) a demonstration of historical and current disparities in the levels of
16 participation of minorities in the manufacturing, distributing, and retail sales tiers of the
17 alcoholic beverages industry in the State through a commissioned and completed disparity
18 study; and

19 (4) consideration and development of legally supportable mechanisms to
20 increase the participation of minorities in each tier of the alcoholic beverages industry in
21 the State by set-aside, by preference, by economic development assistance, or by other
22 appropriate mechanisms.

23 (c) The Office shall conduct the study in consultation and cooperation with:

24 (1) the Office of the Attorney General;

25 (2) the Office of the Comptroller;

26 (3) the Executive Director of the Field Enforcement Division of the Alcohol
27 and Tobacco Commission;

28 (4) the Department of Commerce;

29 (5) the Department of Transportation;

30 (6) local governments and local licensing boards, particularly from
31 jurisdictions with substantial minority populations;

32 (7) representatives of the manufacturing, distributing, and retail sales

1 tiers of the alcoholic beverages industry in the State; and

2 (8) representatives of minority communities in the State.

3 (d) The Office of the Attorney General and the Department of Transportation
4 shall provide staff for the study.

5 (e) On or before January 1, 2022, the Governor's Office of Small, Minority, and
6 Women Business Affairs shall report its findings and recommendations to the Governor
7 and, in accordance with § 2-1257 of the State Government Article, the General Assembly.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
9 1, 2021. It shall remain effective for a period of 1 year and 1 month and, at the end of June
10 30, 2022, this Act, with no further action required by the General Assembly, shall be
11 abrogated and of no further force and effect.
