## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Higher Education – Student Identification Cards – Required Information**

3 FOR the purpose of requiring each institution of higher education to provide the telephone  
4 number for a certain mental health crisis hotline or crisis center on student  
5 identification cards, subject to a certain condition; authorizing an institution of  
6 higher education to provide the telephone numbers for certain mental health crisis  
7 hotlines on student identification cards, subject to a certain condition; providing that  
8 an institution of higher education is not required to reprint or reissue student  
9 identification cards in use on the effective date of this Act in order to comply with  
10 this Act; providing that student identification cards that are printed before the  
11 effective date of this Act will be in compliance with this Act if the cards are issued to  
12 students within a certain time period; and generally relating to required information  
13 on student identification cards.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

2 **IF AN INSTITUTION OF HIGHER EDUCATION PROVIDES AN IDENTIFICATION**  
 3 **CARD TO STUDENTS, THE INSTITUTION:**

4 **(1) SHALL PROVIDE THE TELEPHONE NUMBER FOR MARYLAND'S**  
 5 **HELPLINE, OR AN ON-CAMPUS CRISIS CENTER THAT OPERATES 24 HOURS A DAY**  
 6 **AND 365 DAYS A YEAR, ON THE CARD OR ON A STICKER AFFIXED TO THE CARD; AND**

7 **(2) MAY ALSO PROVIDE THE TELEPHONE NUMBERS FOR THE**  
 8 **NATIONAL SUICIDE PREVENTION LIFELINE, THE CRISIS TEXT LINE, THE**  
 9 **NATIONAL DOMESTIC VIOLENCE HOTLINE, OR AN ON-CAMPUS CRISIS CENTER ON**  
 10 **THE CARD, ANY ON-CAMPUS CRISIS CENTER ON THE CARD OR ON A STICKER**  
 11 **AFFIXED TO THE CARD.**

12 SECTION 2. AND BE IT FURTHER ENACTED, That an institution of higher  
 13 education is not required to reprint or reissue student identification cards in use on the  
 14 effective date of this Act in order to comply with this Act. Any student identification cards  
 15 that were printed, but not issued, before the effective date of this Act will be in compliance  
 16 with this Act if the cards are issued to students not later than 18 months after the effective  
 17 date of this Act.

18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
 19 1, 2021.
