Anne Arundel County - Alcoholic Beverages - Class MT License

3 FOR the purpose of establishing a Class MT (movie theater) beer and wine license in Anne 4 Arundel County; authorizing the Board of License Commissioners for Anne Arundel 5 County to issue the license to the owner of a movie theater who holds a certain 6 certification; authorizing a license holder to sell beer and wine to certain patrons at 7 retail at the place described in the license for on-premises consumption; specifying 8 the hours during which the license holder may sell beer and wine; specifying where 9 and how on the licensed premises beer and wine may be sold; specifying where on the licensed premises beer and wine may be consumed; stating that a license holder 10 11 need not obtain a certain Sunday license; specifying that the license holder is subject 12 to certain alcohol awareness requirements; establishing an annual license fee; and 13 generally relating to alcoholic beverages in Anne Arundel County.

- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 25 That the Laws of Maryland read as follows:

Article - Alcoholic Beverages

- 4 (A) THERE IS A CLASS MT (MOVIE THEATER) BEER AND WINE LICENSE.
- 5 (B) THE BOARD MAY ISSUE THE LICENSE TO THE OWNER OF A MOVIE 6 THEATER THAT HOLDS A CROWD CONTROL TRAINING CERTIFICATION.
- 7 (C) THE LICENSE HOLDER MAY SELL BEER AND WINE AT RETAIL AT THE
- 8 PLACE DESCRIBED IN THE LICENSE FOR ON-PREMISES CONSUMPTION BY A PATRON
- 9 WHO HAS PURCHASED A TICKET TO A CURRENT OR FUTURE SHOWING OF A MOVIE
- 10 ON THE LICENSED PREMISES.
- 11 (D) (1) A LICENSE HOLDER MAY SELL BEER OR WINE BETWEEN THE
- 12 HOURS OF 4 P.M. AND MIDNIGHT.
- 13 (2) BEER AND WINE MAY BE SOLD ONLY:
- 14 (I) IN SINGLE-SERVE CONTAINERS; AND
- 15 (II) FROM A COUNTER SEPARATE FROM A COUNTER SERVING
- 16 FOOD AND NONALCOHOLIC BEVERAGES.
- 17 (E) BEER AND WINE MAY BE CONSUMED ONLY IN THE LOBBY OF THE
- 18 LICENSED PREMISES AND MAY NOT BE CARRIED INTO PUBLIC VIEWING THEATERS.
- 19 (F) A LICENSE HOLDER NEED NOT OBTAIN A SUNDAY LICENSE UNDER §
- 20 11-2004 OF THIS TITLE TO PROVIDE ALCOHOLIC BEVERAGES ON A SUNDAY.

THE ANNUAL LICENSE FEE IS \$1,200.

- 21 (G) THE LICENSE HOLDER IS SUBJECT TO THE ALCOHOL AWARENESS 22 REQUIREMENTS UNDER § 11–1902.1 OF THIS TITLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 25 1, 2021.
