16	(2)	A patron ne	ed not be seated to be served.
17 18	(3) (i) Alcoholic beverages other than beer and wine that are sold or offered for sale shall be purchased from the Liquor Control Board.

21	(d) A holder of the license may sell beer, wine, and liquor:
