Maryland Food System Resiliency Council

- 3 FOR the purpose of establishing the Maryland Food System Resiliency Council; providing for the composition, co-chairs, co-vice chairs, and staffing of the Council; providing 4 5 that a member of the Council may not receive compensation but may be reimbursed 6 for certain expenses; authorizing the Council to establish certain subcommittees; 7 specifying the duties of the Council; requiring the Council to submit certain reports 8 to the General Assembly on or before certain dates; making this Act an emergency 9 measure; defining certain terms; and generally relating to the Maryland Food 10 System Resiliency Council.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
