4 FOR the purpose of extending the deadline for the reporting requirement for the Task Force  
5 on the Economic Future of Western Maryland; extending the termination date for  
6 the Task Force; and generally relating to the Task Force on the Economic Future of  
7 Western Maryland.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 (a) There is a Task Force on the Economic Future of Western Maryland.

1 (g) On or before ~~[January]~~ **OCTOBER** 1, 2021, the Task Force shall report its  
2 findings and recommendations to the Governor and, in accordance with § 2-1257 of the  
3 State Government Article, the General Assembly.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
5 1, 2020. It shall remain effective for a period of 1 year **AND 6 MONTHS** and, at the end of  
6 ~~[June 30]~~ **DECEMBER 31**, 2021, this Act, with no further action required by the General  
7 Assembly, shall be abrogated and no further force and effect.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
9 1, 2021.
