## Anne Arundel County - Hotel Tax Alterations - Distribution of Revenue

3 FOR the purpose of requiring a certain percentage of the hotel tax revenue generated in 4 the City of Annapolis to be distributed to a special fund to be used only to provide 5 funds to the Annapolis Art in Public Places Commission; requiring a certain 6 percentage of the hotel tax revenue generated in the City of Annapolis to be 7 distributed to a certain fund to be used only for housing assistance payments; requiring the Commission to report to the City of Annapolis and certain committees 8 9 and members of the General Assembly on or before a certain date; requiring certain 10 percentages of the hotel tax revenue generated in the City of Annapolis and Anne 11 Arundel County to be distributed to certain special funds; altering a certain 12 reporting requirement; authorizing the County Auditor of Anne Arundel County to 13 conduct an audit of certain organizations; requiring the Auditor to report any audit 14 findings to the County Executive of Anne Arundel County; authorizing Anne Arundel 15 County and the City of Annapolis to withhold funds dedicated to certain 16 organizations under certain circumstances; making a stylistic change; defining 17 certain terms; and generally relating to the hotel tax in Anne Arundel County.

$\frac{1}{2}$	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
3	Article – Local Government
4	20–603.
5	(a) By ordinance, Anne Arundel County may impose a sales or use tax on:
6	(1) fuel and utilities used by commercial and industrial businesses;
7	(2) residential, commercial, and industrial telephone service; and
8 9	(3) space rentals other than space rentals for the docking or storing of boats.
10 11 12	(b) (1) Any revenues collected under subsection (a)(1) and (2) of this section in the City of Annapolis shall be allocated and distributed in equal amounts to the City of Annapolis and to Anne Arundel County.
13 14 15	(2) Except as otherwise provided in this subsection, any revenue generated in the City of Annapolis from the tax on space rentals shall be collected and retained by the City of Annapolis.
16 17 18	(3) Except as provided in paragraph (6) of this subsection, any revenue generated in the City of Annapolis from the hotel tax shall be collected by Anne Arundel County.
19 20	(4) From any revenue generated in the City of Annapolis from the hotel tax, Anne Arundel County shall distribute:
21 22	(I) 3% TO A SPECIAL FUND TO BE USED ONLY TO PROVIDE FUNDS TO THE ANNAPOLIS ART IN PUBLIC PLACES COMMISSION;
23 24	[(i)] (II) 3% to A SPECIAL FUND TO BE USED ONLY TO PROVIDE FUNDS TO the Arts Council of Anne Arundel County, Inc.; and
25 26	[(ii)] (III) 17% to A SPECIAL FUND TO BE USED ONLY TO PROVIDE FUNDS TO the Annapolis and Anne Arundel County Conference and Visitors Bureau; AND
27 28 29	(IV) 3% TO THE AFFORDABLE HOUSING TRUST FUND ESTABLISHED UNDER § 20.30.070 OF THE CODE OF THE CITY OF ANNAPOLIS TO BE USED ONLY FOR HOUSING ASSISTANCE PAYMENTS.

- 1 (5) After making the distributions required under paragraph (4) of this subsection, the balance of the revenue generated in the City of Annapolis from the hotel tax shall be distributed to the City of Annapolis.
- 4 (6) (i) Anne Arundel County may authorize the City of Annapolis to collect revenue generated in the City of Annapolis from the hotel tax.
- 6 (ii) If Anne Arundel County authorizes the City of Annapolis to 7 collect revenue generated in the City of Annapolis from the hotel tax, the City of Annapolis 8 shall distribute a percentage of the revenue in accordance with paragraph (4) of this 9 subsection and retain the balance of the revenue generated.
- 10 (c) (1) From the county's share of revenue from the hotel tax, Anne Arundel 11 County shall distribute:
- 12 (i) 3% to A SPECIAL FUND TO BE USED ONLY TO PROVIDE FUNDS 13 TO the Arts Council of Anne Arundel County, Inc.; and
- 14 (ii) 17% to A SPECIAL FUND TO BE USED ONLY TO PROVIDE 15 FUNDS TO the Annapolis and Anne Arundel County Conference and Visitors Bureau.
- 16 (2) After making the distributions required under paragraph (1) of this subsection, the balance of the county's share of revenue from the hotel tax shall be credited to the general fund of the county.
- 19 (D) (1) ON OR BEFORE NOVEMBER 1 EACH YEAR, THE ANNAPOLIS ART 20 IN PUBLIC PLACES COMMISSION SHALL REPORT ON ITS USE OF HOTEL TAX 21 REVENUE DURING THE PRECEDING FISCAL YEAR TO:
- 22 (I) THE MAYOR AND CITY COUNCIL OF THE CITY OF 23 ANNAPOLIS; AND
- 24 (II) IN ACCORDANCE WITH § 2–1257 OF THE STATE 25 GOVERNMENT ARTICLE, THE SENATE BUDGET AND TAXATION COMMITTEE, THE 26 HOUSE COMMITTEE ON WAYS AND MEANS, AND THE MEMBERS OF THE GENERAL 27 ASSEMBLY REPRESENTING THE CITY OF ANNAPOLIS.
- 28 (2) IF THE ANNAPOLIS ART IN PUBLIC PLACES COMMISSION FAILS
  29 TO SUBMIT THE REPORT REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION,
  30 THE CITY OF ANNAPOLIS MAY WITHHOLD FROM APPROPRIATION SPECIAL FUNDS
