### A BILL ENTITLED

### 1 AN ACT concerning

## Health Occupations - Service Members, Veterans, and Military Spouses Temporary Licensure, Certification, and Registration

4 FOR the purpose of requiring certain health occupations boards to issue a temporary  $\mathbf{5}$ expedited license, certificate, or registration to a service member, veteran, or 6 military spouse who meets certain requirements; providing for the term of a certain 7 temporary license, certificate, or registration; requiring that an application for a 8 certain temporary license, certificate, or registration include certain information; 9 requiring a certain health occupations board to make a certain determination before 10 issuing a certain temporary license, certificate, or registration; authorizing a certain 11 health occupations board to apply to the Secretary of Health for approval of a certain 12alternative process for licensure, certification, or registration for certain individuals 13 for a certain purpose; requiring that a certain health occupations board be considered 14to have fulfilled certain requirements under certain circumstances; authorizing 15certain health occupations boards to issue a temporary license, certificate, or 16registration to certain individuals who hold a certain license, certificate, or 17registration in another state that does not meet certain requirements in the State; 18 providing that a certain temporary license, certificate, or registration authorizes the 19service member, veteran, or military spouse to perform certain services for a certain 20limited period of time under certain circumstances; prohibiting a health occupations 21 board from issuing a certain temporary license, certificate, or registration under 22certain circumstances; and generally relating to temporary health occupational 23licensure, certificate, and registration requirements and service members, veterans, 24and military spouses.

(B) A TEMPORARY LICENSE, CERTIFICATE, OR REGISTRATION ISSUED UNDER THIS SECTION AUTHORIZES THE SERVICE MEMBER, VETERAN, OR MILITARY SPOUSE, FOR A LIMITED PERIOD OF TIME AS DETERMINED BY THE HEALTH OCCUPATIONS BOARD, TO PERFORM SERVICES REGULATED BY THE HEALTH OCCUPATIONS BOARD WHILE THE SERVICE MEMBER, VETERAN, OR MILITARY SPOUSE COMPLETES THE REQUIREMENTS FOR LICENSURE, CERTIFICATION, OR REGISTRATION IN THE STATE.
