## State Board of Dental Examiners – Membership – Nomination and Appointment Process

FOR the purpose of repealing a provision of law that requires the Governor to appoint 4 5 certain members of the State Board of Dental Examiners from a list of names 6 submitted to the Governor by the Board; requiring the Governor to appoint certain 7 members of the Board from a list of qualified individuals submitted by certain 8 organizations and certain petitions submitted to the Secretary of Health and the 9 Governor; repealing a requirement that a certain number of names be submitted for a certain vacancy on the Board; requiring the Board to send a certain notice of 10 11 vacancy to certain licensees and certain organizations that includes certain 12 information and within a certain period of time; repealing a requirement that the 13 Board conduct a certain balloting process; repealing a requirement that the Board 14 develop certain guidelines for the solicitation of nominations and a certain balloting 15 process; and generally relating to nominations and appointments to the State Board 16 of Dental Examiners.
