AN ACT concerning
Commission on Men and Fatherhood
(Fatherhood Protection Act)
FOR the purpose of establishing the Commission on Men and Fatherhood in the Department of Human Services; providing for the composition of the Commission; authorizing the secretaries of certain departments to serve as ex officio nonvoting members; providing for the terms of members of the Commission; providing that a majority of the members serving on the Commission is a quorum; requiring the Commission to elect annually a chair and vice chair; requiring the Commission to meet a certain amount of times per year; providing that a member who fails to attend a certain percentage of regularly scheduled meetings in a certain time period shall be considered to have resigned; prohibiting a member of the Commission from receiving certain compensation, but authorizing reimbursement of certain expenses; requiring the Secretary of Human Services to appoint an Executive Director of the Commission; providing that the Executive Director is entitled to compensation in accordance with the State budget and reimbursement of certain expenses; establishing the duties of the Commission; authorizing the Commission to take certain actions; prohibiting the Commission from adopting regulations; requiring the Commission to report its findings and recommendations to the Governor and the General Assembly on or before a certain date each year; defining a certain term; making this Act an emergency measure; and generally relating to the Commission on Men and Fatherhood.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That the Laws of Maryland read as follows:
Article - Human Services
Subtitle 6. Commission on Men and Fatherhood.

2-601.
In This subtitle, "Commission" means The Commission on Men and FATHERHOOD.

2-602.
There is a Commission on Men and Fatherhood in the Department.

2-603.
(A) THE COMMISSION CONSISTS OF 25 MEMBERS APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE SENATE.
(B) OF THE 25 MEMBERS OF THE COMMISSION:
(1) 12 SHALL BE APPOINTED FROM AMONG APPLICANTS WHO HAVE BEEN NOMINATED AND RECOMMENDED FOR APPOINTMENT BY ORGANIZATIONS LOCATED IN THE STATE WHOSE INTERESTS RELATE TO THE STATUS OF MEN; AND
(2) 13 SHALL BE APPOINTED FROM AMONG APPLICANTS APPLYING ON THEIR OWN BEHALF.
(C) IN ADDITION TO THE MEMBERS APPOINTED UNDER SUBSECTION (B) OF THIS SECTION, THE SECRETARY AND THE SECRETARY OF HEALTH, OR THEIR DESIGNEES, MAY PARTICIPATE IN THE COMMISSION AS EX OFFICIO NONVOTING MEMBERS.
(D) TO THE EXTENT PRACTICABLE, IN MAKING APPOINTMENTS UNDER THIS SECTION, THE GOVERNOR SHALL ENSURE GEOGRAPHIC DIVERSITY AMONG THE MEMBERSHIP OF THE COMMISSION.
(E) (1) THE TERM OF A MEMBER IS 4 YEARS.
(2) A MEMBER MAY NOT SERVE FOR MORE THAN TWO CONSECUTIVE TERMS.
(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL

A SUCCESSOR IS APPOINTED AND QUALIFIES.
(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SHALL SERVE FOR THE REMAINDER OF THE TERM OR UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.
(F) A MEMBER WHO FAILS TO ATTEND AT LEAST 50\% OF THE REGULARLY SCHEDULED MEETINGS OF THE COMMISSION DURING ANY 12-MONTH PERIOD SHALL BE CONSIDERED TO HAVE RESIGNED.
(G) A MAJORITY OF THE MEMBERS PRESENT AT THE MEETING SHALL CONSTITUTE A QUORUM.
(H) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE COMMISSION SHALL DETERMINE THE TIMES, PLACES, AND FREQUENCY OF ITS MEETINGS.
(2) THE COMMISSION SHALL MEET AT LEAST SIX TIMES EACH YEAR.
(I) A MEMBER OF THE COMMISSION:
(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE COMMISSION; BUT
(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE Standard State Travel Regulations, as provided in the State budget.

2-604.
(A) THE COMMISSION ANNUALLY SHALL ELECT THE CHAIR AND VICE CHAIR OF THE COMMISSION.
(B) THE COMMISSION MAY APPOINT ANY OFFICERS THAT IT CONSIDERS NECESSARY.

2-605.
(A) THE SECRETARY SHALL APPOINT AN EXECUTIVE DIRECTOR OF THE COMMISSION.
(B) THE ExECUTIVE DIRECTOR SHALL BE A MERIT EMPLOYEE OF THE DEPARTMENT.
(C) The Executive Director is entitled to:
(1) COMPENSATION IN ACCORDANCE WITH THE STATE BUDGET; AND
(2) Reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.

2-606.

## (A) (1) The Commission shall:

(I) STUDY and review the status of men in the State;
(iI) Strengthen home life by directing attention to CRITICAL PROBLEMS CONFRONTING MEN AS HUSBANDS, FATHERS, HOMEMAKERS, AND WORKERS;
(III) RECOMMEND METHODS OF OVERCOMING DISCRIMINATION AGAINST MEN IN PUBLIC AND PRIVATE EMPLOYMENT AND IN FAMILY LAW DISPUTES;
(IV) ENCOURAGE MEN TO BECOME CANDIDATES FOR PUBLIC OFFICE;
(V) PROMOTE MORE EFFECTIVE METHODS FOR ENABLING MEN TO DEVELOP SKILLS, CONTINUE EDUCATION, AND BE RETRAINED;
(VI) SECURE APPROPRIATE RECOGNITION OF MEN'S aCCOMPLISHMENTS AND CONTRIBUTIONS TO THE STATE;
(VII) WORK TO DEVELOP HEALTHY ATTITUDES WITHIN THE FRAMEWORK OF THE COMMISSION'S RESPONSIBILITIES; AND
(VIII) INFORM THE EXECUTIVE AND LEGISLATIVE BRANCHES OF GOVERNMENT ON ISSUES CONCERNING MEN, INCLUDING OFFERING TESTIMONY ON THE ISSUES SPECIFIED IN THIS PARAGRAPH BEFORE LEGISLATIVE AND administrative bodies.
(2) The Commission may:
(I) ACT AS A CLEARINGHOUSE FOR ACTIVITIES TO AVOID DUPLICATION OF EFFORT; AND
(II) DEVELOP SURVEYS AND APPOINT ADVISORY COMMITTEES

IN FIELDS INCLUDING EDUCATION, SOCIAL SERVICES, LABOR AND EMPLOYMENT, LAW ENFORCEMENT, HEALTH AND SAFETY, LEGAL RIGHTS, FAMILY RELATIONS, HUMAN RELATIONS, AND VOLUNTEER SERVICES.
(B) ON OR BEFORE DECEMBER 1 EACH YEAR, THE COMMISSION SHALL SUBMIT A REPORT ON ITS FINDINGS AND RECOMMENDATIONS TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY ON THE ACTIVITIES OF THE COMMISSION.
(C) THE COMMISSION MAY NOT ADOPT REGULATIONS.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
