Howard County – Fee for Rental Housing Services – Established

Ho. Co. 15–21

4 FOR the purpose of establishing a fee on rental housing licenses issued in Howard County $\mathbf{5}$ for a certain purpose; requiring that the fee be a certain amount in a certain fiscal 6 year and paid at a certain time; specifying that the fee is in addition to any other 7 fees required for the issuance or renewal of a rental housing license; authorizing a governing body to set by resolution the amount of the fee in certain fiscal years; 8 9 providing that the fee shall remain in effect until altered by resolution; providing 10 that certain units shall pay a reduced fee; providing that the fee does not apply to a 11 rental housing license issued to an owner of certain types of housing; authorizing the 12County Executive to designate a county department or other entity, including a nonprofit corporation, to provide certain services; requiring the County to provide 13 14 educational services to certain tenants and landlords; requiring the County to 15provide legal services to certain tenants; requiring the County to begin providing 16 certain services on or before a certain date; defining certain terms; requiring the 17County Executive to submit a certain report to the Howard County Delegation on or 18 before a certain date each year; providing for the application of this Act; and 19generally relating to rental housing license fees in Howard County.

1 (3) (I) BEGINNING IN FISCAL YEAR 2023, THE GOVERNING BODY 2 MAY ALTER THE FEE BY RESOLUTION.

3 (II) A FEE SET UNDER THIS PARAGRAPH SHALL REMAIN 4 EFFECTIVE UNTIL ALTERED BY RESOLUTION BY THE GOVERNING BODY.

5 (4) FOR MODERATE INCOME HOUSING UNITS OR OTHER UNITS FOR 6 WHICH RENTAL RATES ARE RESTRICTED THROUGH FEDERAL, STATE, OR COUNTY 7 AGREEMENTS TO ENSURE LONG-TERM AFFORDABILITY, THE FEE SHALL BE:

(F) ON OR BEFORE DECEMBER 1, 2022, AND EACH DECEMBER 1
THEREAFTER, THE COUNTY EXECUTIVE SHALL PREPARE AND SUBMIT AN ANNUAL
REPORT TO THE HOWARD COUNTY DELEGATION, IN ACCORDANCE WITH § 2–1257
OF THE STATE GOVERNMENT ARTICLE, ON FUNDS COLLECTED, FUNDS SPENT, AND
SERVICES PROVIDED UNDER THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any rental housing license issued or renewed before the effective date of this Act.
