
- 3 FOR the purpose of prohibiting a person, with a certain motivation, from committing a 4 crime or attempting or threatening to commit a crime against a certain first 5 responder or law enforcement officer or group of first responders or law enforcement 6 officers, defacing, damaging, or destroying, or attempting or threatening to deface, 7 damage, or destroy the real or personal property of a certain first responder or law 8 enforcement officer or group of first responders or law enforcement officers, or 9 burning or attempting or threatening to burn an object on the real or personal 10 property of a certain first responder or law enforcement officer or group of first 11 responders or law enforcement officers, or committing another certain crime that 12 involves a separate crime that is a felony or results in the death of a victim; 13 prohibiting a person from defacing, damaging, or destroying, attempting or 14 threatening to deface, damage, or destroy, burn or attempt or threaten to burn an 15 object on, or damage the real or personal property connected to a certain building 16 because a certain person is a first responder or law enforcement officer or group of 17 first responders or law enforcement officers; defining certain terms; establishing that 18 certain penalties apply to a violation of this Act; and generally relating to hate 19 crimes.

2 3	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

6	(a) In this subtitle the following words have the meanings indicated.
7 8 9	(B) "FIRST RESPONDER" MEANS A PERSON ENGAGED IN PROVIDING EMERGENCY MEDICAL CARE OR RESCUE SERVICES, INCLUDING A FIREFIGHTER, AN EMERGENCY MEDICAL TECHNICIAN, OR A RESCUE SQUAD MEMBER.
10	[(b)] (C) "Homeless" means:
11	(1) lacking a fixed, regular, and adequate nighttime residence; or
12	(2) having a primary nighttime residence that is:
13 14	(i) a supervised publicly or privately operated shelter designed to provide temporary living accommodations; or
15 16	(ii) a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings.
17 18	(d) "Law enforcement officer" has the meaning stated in § 3–201 of this article.
19 20	[(c)] (E) "Sexual orientation" means the identification of an individual as to male or female homosexuality, heterosexuality, bisexuality, or gender-related identity.

22 23 24 25 26	Motivated either in whole or in substantial part by another person's or group's race, color, religious beliefs, sexual orientation, gender, disability, or national origin, BECAUSE ANOTHER PERSON IS A LAW ENFORCEMENT OFFICER OR A MEMBER OF A GROUP OF LAW ENFORCEMENT OFFICERS, OR A FIRST RESPONDER OR MEMBER OF A GROUP OF FIRST RESPONDERS, or because another person or group is homeless, a person may not:
27 28	(1) (i) commit a crime or attempt or threaten to commit a crime against that person or group;
29	(ii) deface, damage, or destroy, or attempt or threaten to deface,

damage, or destroy the real or personal property of that person or group; or



28 (a) Except as provided in subsection (b) of this section, a person who violates this subtitle is guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 3 years or a fine not exceeding \$5,000 or both.

- 1 (b) (1) A person who violates § 10–304(2)(i) of this subtitle is guilty of a felony 2 and on conviction is subject to imprisonment not exceeding 10 years or a fine not exceeding 3 \$10,000 or both.
- 4 (2) A person who violates § 10–304(2)(ii) of this subtitle is guilty of a felony and on conviction is subject to imprisonment not exceeding 20 years or a fine not exceeding 6 \$20,000 or both.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2021.
